BACKGROUND:

Summary

In accordance with California Elections Code §§ 15301, 15372 and 15374, the official canvass of votes for the December 13, 2022 City of Banning Recall Election has been completed and is forwarded for acceptance by the Board. Attached is the Certificate of the Registrar of Voters and the Statement of Votes cast.

On December 6, 2022, the Board of Supervisors approved the conduct of election services for the City of Banning Recall Election. The County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election.

The election was successfully held on December 13, 2022 with 54.21% turnout. Staff recommends that the Board accepts the results of the official canvass of votes cast for this Consolidated General Election.

Impact on Residents and Businesses

Registered voters in the City of Banning, Council District 3 had the opportunity to vote to recall the Council Member for District 3.

Additional Fiscal Information


As approved by the Board of Supervisors on December 6, 2022, the County will receive reimbursements from the jurisdiction based on associated direct costs of conducting their election. Approximately \$18,000 of election costs will be reimbursed by the City of Banning.
