The Board of Supervisors commemorates her service to the County of Riverside.



He attended California State University, San Marcos where he received his Bachelor's Degree in Criminology and Justice Studies. On March 26, 2017, he was joined in holy matrimony to Vanessa Nichele Quinn. Darnell was a devoted husband, loving father, and his family was often the main topic of his conversations.
