## BACKGROUND:

## <u>Summary</u>

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution No. 2022-044 adopted December 13, 2022 (Agenda Item 3.49), the Board of Supervisors gave notice of a public hearing for January 31, 2023, to receive testimony regarding the Annexation of Street Lighting Zone 156 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated (L&LMD No. 89-1-C). Annexation of Street Lighting Zone 156 will fund the maintenance and servicing of streetlights within public rights-of-way located north of Martin Street, south of Perry Street, east of Seaton Avenue and west of Harvill Avenue in the Mead Valley area and includes one commercial parcel totalling 10 acres.

The annexation of territory to an existing assessment district formed under the Landscaping and Lighting Act is a change of organization that requires a public hearing as part of the annexation process. Sts. & Hy. Code §§ 22605(a), 22607, 22588; Gov't. Code § 53753(d).

On December 14, 2022, a notice of the public hearing and information sheet, a mail-in assessment ballot, an impartial analysis, and a copy of Resolution No. 2022-044 was mailed to all property owners within Street Lighting Zone 156, proposed for annexation to L&LMD No. 89-1-C. Pursuant to the notice, all assessment ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2022-044 in an appropriate newspaper at least ten (10) days prior to the public hearing date and by posting a certified copy of Resolution No. 2022-044 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two (2) other public locations within the County.

#### Impact on Residents and Businesses

The new assessment is for the purpose of providing the maintenance and servicing of streetlights within public right-of-way.

Only the commercial property owners within the proposed boundaries of Street Lighting Zone 156, which are represented by Plot Plan Tentative No. 180025 (PPT180025), as described in the attached Exhibit "A" (a two-page exhibit containing a description and diagram) are impacted by the cost of this annexation. The property owners within the proposed boundaries of Street Lighting Zone 156 have petitioned the County of Riverside to annex their property to L&LMD No. 89-1-C and understand that this annexation will result in an assessment on their property to fund the maintenance and servicing of the aforementioned improvements (streetlights).

#### SUPPLEMENTAL:

#### Additional Fiscal Information

The proposed budget for fiscal year 2023-24 for Street Lighting Zone 156 is \$638. This will result in an assessment for fiscal year 2023-24 within Street Lighting Zone 156 of \$70 per acre. The annual assessment may be adjusted annually by the greater of 2% or the cumulative percentage increase in the Consumer Price Index for all Urban Consumers for electricity (CPI-U\_Electricity), if any, as it stands as of March of each year over the base index for March of 2022.

# BACKGROUND: Summary

Landscaping and Lighting Maintenance Districts (L&LMDs) are formed for the purpose of creating a funding mechanism to pay for the installation and maintenance of landscaping, streetlights, traffic signals, runoff catch basin filters, decorative fencing, and other roadside features within the road right of way. Within an established L&LMD, zones are created for specific developments, a fee structure is developed specific to the features within that zone, and the zone is then assessed through a tax levy on an annual basis for the installation and maintenance of the features within that particular zone.

L&LMD No. 89-1-C was formed in 1994, Resolution No. 94-389, and currently consists of 166 individual zones with different fee structures spread throughout Riverside County. The commercial property owner of Plot Plan Transmitted No. 180025 (PPT180025), as described in the attached Exhibit "A", has petitioned the County to annex their property into L&LMD No. 89-1-C, creating Street Lighting Zone 156. The boundaries of Street Lighting Zone 156 will encompass the entire PPT180025 and will include the maintenance and servicing of streetlights.

Adoption of Resolution No. 2022-043 appoints the Director of the Transportation Department, or their designee, as the Engineer to prepare a Report regarding the proposed annexation of Street Lighting Zone 156 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LMD No. 89-1-C").

Resolution No. 2022-044 declares the Board of Supervisors' intention of ordering the annexation of Street Lighting Zone 156 to L&LMD No. 89-1-C. The annexation of Street Lighting Zone 156 to L&LMD No. 89-1-C will fund the maintenance and servicing of streetlights within public right-of-way located north of Martin Street, south of Perry Street, east of Seaton Avenue and west of Harvill Avenue in the Mead Valley area and includes one commercial parcel totalling 10.00 acres.

Consistent with the Board of Supervisors' direction regarding compliance with Article XIIID of the California Constitution and the Landscaping and Lighting Act of 1972, the attached resolutions have been prepared and a public hearing scheduled for 9:30 a.m. on January 31, 2023 to receive testimony for and against the proposed assessment. Each property owner

within the proposed Street Lighting Zone 156 will receive a notice of the public hearing and mailin assessment ballot, an impartial analysis, a copy of Resolution No. 2022-044, and an information sheet.

Assessment ballots must be returned prior to the conclusion of the public hearing. If, at the time designated for the tabulation of the assessment ballots, the assessment ballots submitted in favor of the annexation and levy of the assessment exceed the assessment ballots submitted in opposition of said annexation and levy, Street Lighting Zone 156 will be annexed to L&LMD No. 89-1-C.

There is only one individual/entity which owns all of the property within the proposed boundaries of Street Lighting Zone 156 and said property owner has executed a "Waiver and Consent Regarding Date of Assessment Ballot Proceeding" allowing for the proceeding and public hearing to be held on January 31, 2023.

#### **Reference**

At the direction of the County of Riverside Board of Supervisors, L&LMD No. 89-1-C was formed in 1994 by Resolution No. 94-389 authorizing the annexation of new zones into L&LMD No. 89-1-C for the purpose of levying assessments to pay for the installation and maintenance of landscaping, streetlights and other right-of-way approved improvements.

The zone specific Engineer's Report for fiscal year 2023-24 was prepared in compliance with the requirement of Article 4, Chapter 1, of the Landscaping and Lighting Act of 1972, which is Part 2, Division 15 of the California Streets and Highways Code. The County initiates annexation proceedings for the annual levy of assessments by passing a resolution, which proposes the new levy under the Landscaping and Lighting Act of 1972. This resolution also describes the improvements, describes the location of the zone within the District and finally orders an engineer, who is a registered professional engineer, certified by the State of California, to prepare and file a detailed report.

In November 1996, California voters passed Proposition 218, Right to Vote on Taxes Act which added Articles XIII C and XIII D to the California Constitution, new procedures must be followed to levy annual assessments under the Landscaping and Lighting Act of 1972. A County may levy annual assessments for an assessment district after complying with the requirements of the Landscaping and Lighting Act of 1972, and the provisions of Proposition 218 Right to Vote on Taxes Act.

#### Impact on Residents and Businesses

The new assessment is for the purpose of providing the maintenance and servicing of streetlights within public right-of-way.

Only the commercial property owners within the proposed boundaries of Street Lighting Zone 156, which are represented by PPT180025, as described in the attached Exhibit "A" (a two page exhibit containing a description and diagram) are impacted by the cost of this annexation. By setting up an assessment for the maintenance of certain infrastructure required by the development, the County requires that the development pay for its maintenance impact, rather than the obligation falling upon public funding sources.

#### SUPPLEMENTAL: Additional Fiscal Information

The proposed budget for fiscal year 2023-24 for Street Lighting Zone 156 is \$638. This will result in an assessment for fiscal year 2023-24 within Street Lighting Zone 156 of \$70 per acre. The annual assessment may be adjusted annually by the greater of 2% or the cumulative percentage increase in the Consumer Price Index for all Urban Consumers for electricity (CPI-U), if any, as it stands as of March of each year over the base index for March of 2022.

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE DECLARING ITS INTENT TO ORDER THE ANNEXATION OF STREET LIGHTING ZONE 156 TO LANDSCAPING AND LIGHTING MAINTENANCE DISTRICT NO. 89-1-CONSOLIDATED OF THE COUNTY OF RIVERSIDE PURSUANT TO THE LANDSCAPING AND LIGHTING ACT OF 1972 FOR THE MAINTENANCE AND SERVICING OF STREETLIGHTS; ADOPTING THE PRELIMINARY ENGINEER'S REPORT; GIVING NOTICE OF AND SETTING THE TIME AND PLACE OF THE PUBLIC HEARING ON THE THE ANNEXATION OF STREET LIGHTING ZONE 156 ; ORDERING AN ASSESSMENT PROCEEDING; ORDERING AN ASSESSMENT BALLOT PROCEEDING CONDUCTED BY MAIL; AND DIRECTING NOTICE OF THE PUBLIC HEARING AND THE ASSESSMENT BALLOT TO BE MAILED PURSUANT TO SAID ACT AND ARTICLE XIID OF THE CALIFORNIA CONSTITUTION AND SECTION 4000 OF THE ELECTIONS CODE

WHEREAS, the Board of Supervisors (hereinafter the "Board of Supervisors") of the County of Riverside (hereinafter the "County") has adopted Resolution No. 2022-043 on December 13, 2022 initiating proceedings for the annexation of Street Lighting Zone 156 (hereinafter "Street Lighting Zone 156"), as described and shown in Exhibit "A", which is attached hereto and incorporated herein, to Landscaping and Lighting Maintenance District No. 89-1-Consolidated of the County of Riverside, State of California, (hereinafter "L&LMD No. 89-1-C") pursuant to the Landscaping and Lighting Act of 1972 (hereinafter the "Act"), which is Part 2 (commencing with Section 22500) of Division 15 of the Streets and Highways Code (hereinafter the "Streets and Highways Code"), and ordering the preparation of a report (hereinafter the "Report") regarding the proposed annexation of Street Lighting Zone 156 and the assessments to be levied within Street Lighting Zone 156 each fiscal year beginning fiscal year 2023-24 for the maintenance and servicing of streetlights within the public right-of-way within said zone; and

WHEREAS, such proceedings shall comply with the requirements of Article XIIID of the California Constitution (hereinafter "Article XIIID"), the Act, and Section 4000 of the Elections Code requiring voter approval of the proposed assessment to be levied by L&LMD No. 89-1-C for Street Lighting Zone 156; and

WHEREAS, the Board of Supervisors by Resolution No. 2022-043 directed the Director of the Transportation Department, or their designee (hereinafter the "Engineer"), to prepare and file the Report

3 WHEREAS, said Engineer has filed the Report with the Clerk of the Board of Supervisors and the 4 Report has been presented to and considered by the Board of Supervisors; and

WHEREAS, the Applicant has executed a "Waiver and Consent Regarding Date of Assessment Ballot Proceeding" allowing for the proceeding to be held on January 31, 2023; and

WHEREAS, it is necessary that the Board of Supervisors adopt a resolution of intention pursuant 7 to Section 22587 of the Streets and Highways Code, which fixes and gives notice, pursuant to Section 22588 of the Streets and Highways Code, of the time and place of a public hearing on said Report, the annexation of Street Lighting Zone 156, and the assessments to be levied on parcels within Street 10 Lighting Zone 156 beginning in fiscal year 2023-24;

NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED by the Board of Supervisors in regular session assembled on December 13, 2022 as follows:

Section 1. Findings. The Board of Supervisors, after reviewing the Report, finds that:

- The foregoing recitals are true and correct; (a)
- The Report contains all matters required by Sections 22565 through 22574 of the Streets (b) and Highways Code and Section 4 of Article XIIID and may, therefore, be approved by the Board of Supervisors;

(C) The annual assessment for fiscal year 2023-24 on all parcels within Street Lighting Zone 156 will be \$70 per acre.

Section 2. Intent. The Board of Supervisors hereby declares its intention to order the 21 annexation of Street Lighting Zone 156, as described and shown in Exhibit "A", to L&LMD No. 89-1-C, 22 and to levy and collect an annual assessment on all assessable lots and parcels of property within Street 23 Lighting Zone 156 commencing with the fiscal year 2023-24 as set forth in the Report. The Report 24 expressly states that there are no parcels or lots within Street Lighting Zone 156 that are owned by a 25 federal, state or other local governmental agency that will benefit from the services to be financed by the 26

annual assessments. The annual assessments will be collected at the same time and in the same manner
 as property taxes are collected, and all laws providing for the collection and enforcement of property
 taxes shall apply to the collection and enforcement of said assessments.

Section 3. <u>Boundaries.</u> All the property within the boundaries of Street Lighting Zone 156 is
proposed to be annexed to L&LMD No. 89-1-C and shall include that property in the unincorporated area
of the County as described and shown in Exhibit "A".

 Providing electricity to and the maintenance and servicing of streetlights within the public right-of-way including incidental costs and expenses.

11 Section 5. **Amount to be Levied.** The assessment to be levied upon each parcel that benefits 12 from the annexation of Street Lighting Zone 156 to L&LMD No. 89-1-C will be \$70 per acre for fiscal year 13 2023-24. As stated in the Report, the total budget for Street Lighting Zone 156 for the fiscal year 2023-14 24 is \$638; there is 1 parcel that is to be assessed that aggregates to 9 acres. Each succeeding fiscal 15 year the special assessment may be subject to an annual adjustment that is the greater of two percent 16 (2%) or the cumulative percentage increase, if any, in the Consumer Price Index for all Urban Consumers 17 for electricity ("CPI-U") for the Riverside-San Bernardino-Ontario California Standard Metropolitan 18 Statistical area ("Index") published by the Bureau of Labor Statistics of the United States Department of 19 Labor. The annual CPI-U adjustment will be based on the cumulative increase, if any, in the Index as it 20 stands on March of each year over the base Index for March of 2022. Any increase larger than the greater 21 of 2% or the CPI-U annual adjustment requires a majority approval of all the property owners in Street 22 Lighting Zone 156. The Board of Supervisors will levy the assessment in each subsequent fiscal year 23 until the Board of Supervisors undertakes proceedings for the dissolution of Street Lighting Zone 156 of 24 L&LMD No. 89-1-C. The annual assessment will fund the services described in Section 4 of this 25 Resolution. For further particulars, reference is to be made to the Report on file in the Office of the Clerk 26 of the Board of Supervisors.

1 Section 6. The Property to be Annexed. The property to be annexed to L&LMD No. 89-1-C is Street Lighting Zone 156. The boundaries of Street Lighting Zone 156 are located within the unincorporated area of the County and are described and shown in the Report and Exhibit "A".

**Report.** The Report, which is on file with the Clerk of the Board of Supervisors and Section 7. which has been presented to the Board of Supervisors, is hereby approved. Reference is made to the Report for a full and detailed description of the services, the boundaries of Street Lighting Zone 156, and the annual assessment to be levied upon assessable lots and parcels within Street Lighting Zone 156 proposed to be annexed to L&LMD No. 89-1-C.

9 Section 8. Public Hearing. The question of whether Street Lighting Zone 156 shall be 10 annexed to L&LMD No. 89-1-C and an annual assessment levied beginning with fiscal year 2023-24 shall 11 be considered at a public hearing (hereinafter the "Public Hearing") to be held on January 31, 2023, at 12 9:30 a.m. at the meeting room of the Board of Supervisors of the County at 4080 Lemon Street, 1<sup>st</sup> Floor, Riverside, California. 13

14 Section 9. Majority Protest. Each owner of record of property within Street Lighting Zone 156 is to receive by mail an assessment ballot that shall conform to the requirements of Section 4 of Article 15 XIIID and Section 4000 of the California Elections Code. The assessment ballots are to be returned prior 16 17 to the Public Hearing. The agency shall not impose an assessment if there is a majority protest. A majority 18 protest exists if, upon the conclusion of the hearing, assessment ballots submitted in opposition to the 19 assessment exceed the assessment ballots submitted in favor of the assessment. In tabulating the 20 assessment ballots, the assessment ballots shall be weighted according to the proportional financial 21 obligation of the affected property.


1	Section 11. Notice of the Public Hearing. Notice of Public Hearing with regard to the

10	Street Lighting Zone 156 as shown on the last equalized assessment roll of the County. Mailing is to be
11	made by the Engineer and deposited with the U.S. Post Office at least forty-five (45) days prior to the
12	Public Hearing on January 31, 2023.
13	Section 12 <u>Effective Date.</u> This Resolution shall take effect from and after its date of adoption.
