## BACKGROUND/APPOINTEE INFORMATION:

The Riverside County Children and Families Commission (RCCFC) was established by this Board in the adoption of Ordinance 784, enacted on January 22, 1999. The Commission implements the provisions of Proposition 10, which provides tobacco tax funds to facilitate the creation and implementation of an integrated, comprehensive, and collaborative system of information and services to enhance optimal early childhood development and to ensure that children are ready to enter school.

Elizabeth Romero is a Board Trustee on the Riverside County Office of Education with over 17 years of experience as a school board member.
