



**BACKGROUND:**

The Riverside County Workforce Development Board (WDB) is a private sector led policy and oversight body that supports economic expansion and the development of the regional workforce. The WDB is governed by the Workforce Innovation and Opportunity Act of 2014 (WIOA) which mandates that 50% of the WDB's members must come from the business community. In addition, WDBs are required to have representation from universities or community colleges and other training providers, as well as economic development and workforce program leaders. This ensures that federal funds for workforce development activities are expended on training and career coaching that meets the needs of the business community. Pursuant to WIOA, the Board of Supervisors, led by the Board Chairman who serves as the Chief Local Elected Official (CLEO), is responsible for appointing the WDB members for two-year terms.

Mr. Jeremey Shumaker currently serves as the Senior Regional Director of Operations for the American Medical Response and REACH Air Medical in Riverside County. Mr. Shumaker grew up in Riverside County and has worked in Emergency Medical Services since 1997. He is a military veteran, having served in the United States Army for eight years as a Combat Medic including a tour in Iraq in 2003. Mr. Shumaker holds a bachelor's degree from Colorado State

University in Organizational Leadership and has served on several boards and advisory committees during his career including, but not limited to, the Workforce Development Board of Ventura County, South-Central Coast Regional Consortium Grant Selection Committee, California Community College Chancellors Office, Health Workforce Initiative Advisory Committee, Riverside University Health System Foundation Board of Directors, March ARB Honorary Base Commander, Leadership Riverside Cohort '23 and EMS Career Pathways Apprenticeship, Program Chair. Healthcare is one of the in-demand industries identified by the Riverside County Workforce Development Board. Mr. Shumaker's experience in the healthcare industry as well as with the Workforce Development Boards and committees in Education and Healthcare, make of him an asset to the WDB as they develop and expand career pathways in healthcare.

Mr. Jeremy Shumaker has confirmed his interest in serving on the WDB as a Private Sector Representative in Business for the First District. If appointed he will serve a two-year term commencing February 07, 2023, through February 06, 2025.
