BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The donation to Fair Housing Council of Riverside County, Inc, (\$2,500.00) will be used for the 2023 Housing Conference. FHCRC assists individuals with foreclosures, homelessness affordable housing shortages, high rental control and lack of funding for housing programs.
2. The donation to Hazel's Hands Inc. (\$1,000.00) will be used for My Bedding and My Bag program. The program provides new bedding to newly placed and already placed foster children.
3. The donation to Jurupa Valley Citizens Patrol (\$2,000.00) will be used for the Jurupa Valley Station Volunteer Program. It will help fund the purchase of reflective traffic cones, LED Flare lighting and balloon style area lighting and reflective safety vests that will assist the volunteers in all aspects of their services to the communities.
