BACKGROUND:

<u>Summary</u>

The Sheriff's Department is requesting approval to purchase eleven (11) vehicles totaling \$539,915. The vehicles requested were not part of the fiscal year budget request, however they are urgently needed to support the expansion of new operations and assist the California Public Records Act (CPRA) Unit's compliance with Senate Bill 2 (SB2). The Unit consists of members who use specialized training to aid in the investigation, reporting, and recordkeeping requirements mandated by SB2. The additional vehicles are needed to replace eight (8) vehicles that went out of service unexpectedly due to mechanical failure or vehicles that are incurring high repair cost. The purchase of these vehicles will reduce the repair cost as well as support the day-to-day functions of the department and County.

The Department plans on making a cash purchase for ten (10) vehicles and financing one (1) vehicle in the amount of \$539,915 using the Sheriff's budget.

Contract History and Price Reasonableness

The vehicles requested through Fritts Ford are items currently available to purchase and they are on the existing bid award PUARC 1650. The vehicles requested from National Auto Fleet Group have been competitively bid and awarded through the Sourcewell cooperative agreement No. 091521-NAF.

Impact on Residents and Businesses

The vehicles will be used to conduct Department business and to support the day-to-day functions of the department and County.

Additional Fiscal Information

The current fiscal cost for eleven (11) vehicles listed in the amount of \$539,915 includes all costs associated with the purchase and/or finance of the vehicles.
