

BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

1. Murrieta/Wildomar Chamber of Commerce - \$1,000.00: The funding will be used for a business expo. This event brings together hundreds of business professionals and community members to build businesses in Southwest Riverside County.
2. Beloved Foundation - \$5,000.00: The funding will be utilized to serve cancer patients and caregivers, who struggle with the financial burden of stage IV or terminal cancer diagnosis in the family.
3. JDS Creative Academy - \$2,500.00: The funding will be used for the ADA Facility Expansion to serve clients from the Inland Regional Center (IRC).
4. Fair Housing Council of Riverside County - \$1,000.00: The funding will be utilized for the 2023 Housing Conference, which brings together community, non-profits, and housing providers to resolve housing issues in Riverside County.
5. California Family Life Center - \$1,000.00: The funding will be used for the annual fundraiser, which funds support services that help provide children, youth, and families stability with basic needs.

6. City of Menifee - \$5,000.00: The funding will be utilized for support services, e.g., equipment and logistics, to bring 'The Wall That Heals' to Menifee. The Wall That Heals exhibit is a replica of the Vietnam Veterans Memorial in Washington, D.C.
