#### **BACKGROUND:**

#### **Summary**

On March 11, 2021, President Biden signed the American Rescue Plan Act of 2021 (H.R. 1319) into law. The \$1.9 trillion package is intended to combat the COVID-19 pandemic, including the public health and economic impacts.

As part of the \$362 billion in federal fiscal recovery aid for state and local governments, \$65.1 billion is provided in direct aid to counties. Riverside County's share of the American Rescue Plan funding is estimated to be \$479 million, of which the first installment of \$239,937,299 was received on May 10, 2021, and the second of equal amount on June 6, 2022. Funds must be obligated by December 31, 2024 and expended by December 31, 2026.

On April 27, 2021, the Executive Office presented the Board of Supervisors with a preliminary ARPA funding allocation and on October 19, 2021, presented a revised funding allocation after the U.S. Treasury released the ARPA funding guidelines. The funding allocation obligates funds to 7 categories: Infrastructure, Housing & Homelessness, Economic Recovery, County Departments Response, Non-Profit Assistance, Child Care and Revenue Backfill.

On February 8, 2022, the Executive Office presented the Board of Supervisors with a revised ARPA allocation which was primarily driven by a \$12M reduction in the Revenue Backfill (Attachment A – Updated ARPA 1<sup>st</sup> Installment Allocation Infographic). On October 4, 2022, the Board of Supervisors approved the 2<sup>nd</sup> ARPA Installment Allocation (Attachment B - ARPA 2<sup>nd</sup> Installment Allocation Infographic).

In November of 2022, the U.S. Department of the Treasury announced the release of the first round of Local Assistance and Tribal Consistency Fund (LATCF) payments, providing \$1.5 billion in two equal payments of \$750 million to eligible counties for FYs 2022 and 2023. The fund is a general revenue enhancement program that provides

additional assistance to eligible revenue sharing counties and eligible Tribal governments under the American Rescue Plan Act (ARPA). Riverside County was allocated \$12 million of which \$6 million has been received. The Treasury expects to make the second payment in calendar year 2023.

The LATCF eligible uses include but are not limited to:

- Provision of health services, educational services, court services, police, fire, emergency medical, and other public safety services, utilities or sanitation services, and direct assistance to households (including cash assistance).
- Capital expenditures on core facilities and equipment, including in housing and community development (e.g., schools, hospitals, childcare facilities, and parks and recreation facilities), public safety facilities and equipment (e.g., police vehicles), and government administration buildings.
- Infrastructure investments, including roads, bridges, water and sewer systems, utility systems, airports, public transit, and technology infrastructure;
- Long-term economic development activities, including affordable housing development, workforce development and other programs to strengthen local communities undergoing economic transitions.
- General government operations, such as general government administration, personnel costs, administrative facilities, record keeping, tax assessments, or election administration; and

LATCF funding is not subject to Davis Bacon (with exceptions), can be used to match non-federal matching requirements and all infrastructure projects are subject to Build American, Buy American unless a waiver is submitted and approved.

On October 4, 2022, the Board approved the distribution of the 2nd ARPA installment to a Countywide allocation (\$49 million), allocation by district (\$165 million / \$33 per district) and a future allocation (\$25 million). The Executive Office is recommending to include the LATCF funds under the future allocation category for a total allocation of \$31 million (\$37 million upon the County's receipt of the second LATCF payment) for the Board's future programming.

#### Infrastructure

The County obligated \$61.7 million (80%) of its Infrastructure ARPA allocation in the amount of \$82 million to 22 county-wide water, sewer, and broadband projects.

#### Housing, Homelessness and Neighborhood Revitalization

The County obligated \$40.1 million (68%) of its allocation in the amount of \$56.2 million to projects aimed to expand emergency shelter, permanent supportive housing, and affordable housing countywide in addition to 2 neighborhood revitalization projects in Districts 1 & 2.

#### **Economic Recovery**

The County obligated \$26.6 million (73%) of its Economic Recovery allocation in the amount of \$36 million in support of county-wide Tourism Recovery Campaign, Business Revitalization, Edward Dean Museum Revitalization and Paving projects.

#### **County Departments Response**

The County obligated \$23.2 million (75%) of its County Departments Response allocation in the amount of \$30.9 million. The obligations included ARPA eligible administrative expenses, COVID-19 testing kits for asylum seekers, salary reimbursements for re-purposed labor associated with the ARPA funding administration effort and uninsured costs for COVID care, vaccination, supplies and personal protective equipment incurred in FY 21/22.

#### Non-profit Assistance

Our non-profits provide essential community support services that will assist in our recovery and increase our resiliency as a County moving forward. The Board approved the allocation of \$1 million for the establishment of the Coronavirus Recovery Community Improvement Designation Funds to support non-profit organizations responding to the public health emergency or the negative economic impacts of COVID-19 within Riverside County. As of January 31, 2023, the Board approved 85 non-profits ARPA CID applications in the amount of \$802,000.

On July 26, 2022, the Board of Supervisors approved the allocations of \$15 million in ARPA funding to establish the Riverside County Non-Profit Roundtable to build a public-

private-community partnership that would ensure a strong local network of services to address the ongoing needs of the county's most vulnerable residents and communities. The Board of Supervisors approved the Roundtable's funding framework which recommended funding for two large scale competitive grant programs: 1) the first grant program would target nonprofits negatively impacted by the pandemic and 2) the second program would support nonprofit programs and services targeted to disproportionately impacted communities. A small portion of funding has been reserved to provide technical assistance to participating nonprofits to increase financial viability and long-term sustainability. The grant funding will be deployed by an intermediary agency that is selected through a competitive process. The Request for Proposals for this agency was released in January and the agreements are scheduled to come before the Board for approval in March. The first funding rounds for the grant programs will be available in April with subsequent rounds occurring at regular intervals.

#### **Child Care**

ARPA also provides eligibility for programs and efforts supporting the return of working parents to the workforce including early care and education retention, recruitment, and expansion of workforce, providers, and facilities. On September 14, 2021, the Board approved the allocation of \$15 million for the establishment of Early Care & Education (ECE) Recovery Fund to stabilize and expand availability of ECE to support the return of working parents to the workforce.

As of February 22, 2023, the entire \$10,000,000 from the 1st ARPA allocation has been paid to 6,822 early childhood educators. As it relates to Child Care infrastructure, the Board of Supervisors approved obligating \$1 million in ARPA Child Care funds to District 1 – Lakeland Village Child Care project (BOS Item 3.8, ID#18696). The Executive Office, First Five and Facilities Management are currently developing the bid strategy that would potentially allow for a variety of competitive bids.

#### Revenue Backfill

The County elected to receive the standard \$10 million revenue backfill allowance which was expended towards ARPA eligible County services for Homelessness, RUHS-FQHCs and Economic Development.

#### District 1

On December 12, 2022, the Board of Supervisors approved the obligation of \$18.4 million from the 1<sup>st</sup> District 2<sup>nd</sup> ARPA allocation in the amount of \$33 million for various neighborhood revitalization projects including sidewalks, crosswalk signalization, streetlights and improvements/expansions at the Lakeland, Good Hope and Mead Valley parks / community centers.

#### **District 2**

On January 24, 2023, the Board of Supervisors approved the obligation of \$1.8 million from the 2<sup>nd</sup> District 2<sup>nd</sup> ARPA allocation in the amount of \$33 million for the Boys and Girls Club in Lake Elsinore for the Alberhill Ranch Clubhouse improvements project. The ARPA funding will support necessary improvements to the Clubhouse thus, preparing it for re-opening for continued childcare services.

#### **District 4**

On January 31, 2023, the Board of Supervisors approved the obligation of \$6.7million to Palm Communities, a California corporation and affordable housing developer, for the Palm Villas at Millennium Housing project. Of the \$6.7 million obligated, \$2,260,000 will be drawn for district 4 1<sup>st</sup> ARPA allocation and the remaining \$4,440,000 will be drawn from the 2<sup>nd</sup> ARPA allocation for District 4.

#### **County-wide Child Care**

On January 24, 2023, the Board of Supervisors approved \$8,000,000 in county-wide Childcare from the ARPA 2<sup>nd</sup> allocation for Early Care & Education (ECE) Recovery Fund to stabilize and expand availability of ECE to support the workforce. As of February 22, 2023, \$1,599,877 have been paid out to 667 early childhood educators.

#### **Additional Fiscal Information**

As of January 31, 2023, the County has obligated \$192.7 million (80%) of its 1<sup>st</sup> ARPA allocation and \$32.6 million (14%) of its 2<sup>nd</sup> ARPA allocation.
