2. Adopt Resolution #2023-061 authorizing the Behavioral Health Director to sign the Agreement, related documents, reports and amendments.



BACKGROUND:

Summary

Since July 21, 1998, the Board of Supervisors has continuously approved the agreements between DHCS and Riverside University Health System–Behavioral Health (RUHS-BH) to provide Medi-Cal Specialty Mental Health Services (SMHS) to beneficiaries in Riverside County.

Standard Agreement #22-20124 specifies the Federal and State requirements that counties must meet to participate as a Mental Health Plan (MHP) and claim Federal Financial Participation (FFP) for SMHS provided. SMHS includes: mental health treatment services, medication support, intensive day treatment, day rehabilitation, crisis intervention, adult and crisis residential treatment services, psychiatric health facility services, Intensive Care Coordination, Intensive Home Based Services, Therapeutic Behavioral Services, Therapeutic Foster Care, Psychiatric Inpatient Hospital Services and Targeted Case Management.

Impact on Residents and Businesses

These services are a component of the Department’s system of care aimed at improving the health and safety of the communities of Riverside County.

Additional Fiscal Information

On August 20, 2013 (#3.53) Standard Agreement #12-89385 was approved by the Board covering the term May 1, 2013 through June 30, 2018. On July 31, 2018 (#3.34) Amendment #A01 to Agreement #12-89385 was subsequently approved by the Board to adjust the period of performance of the original agreement, and establish Standard Agreement #17-94604 for the term July 1, 2018 through June 30, 2022.

As with the aforementioned agreements, Standard Agreement #22-20124 is a zero dollar contract. RUHS-BH’s authority to be reimbursed by DHCS is established in accordance with Chapter 3, Part 2, Division 5 of the Welfare and Institution Code along with Sections 5600, 5750, 5650, and Government Code Sections 11138, 14705 and 14718. Therefore, DHCS is not required to develop and include individual county funding estimates for the five-year term of the contract. Reimbursements are made to RUHS-BH on a claims basis. No additional County funds are required.

16 of Riverside is responsible for establishing community mental health services to cover the entire area of
17 the County;

18 WHEREAS, the County of Riverside is committed to providing and integrated and coordinated
19 range of services appropriate to the needs of each client;

21 Supervisors of the County of Riverside, in regular session assembled on March 28, 2023, does
