We would like to address what policies and procedures are in place to protect STR owners from ongoing bogus complaints alleged by a neighbor who is vehemently against STRs. In spite of our efforts to work with our neighbor over the last 2.5 years, we continue to receive angry & threatening texts with videos about "complaints". We are concerned that these complaints will jeopardize our ability to run our family cabin (a place we call our second home).

The same neighbor has terrorized our guests, helpers, and friends who came to visit. He lost his voice once screaming at a young kid who was plowing snow. He placed surveillance cameras 20 feet up on his trees that were aimed DIRECTLY AND PURPOSEFULLY into one of our bedrooms. The sign below the camera stated "smile you're on camera". He also placed NO TRESPASSING signs on OUR side of the fence that were in direct sight from the downstairs bedroom. He peers over our fence to take pictures of our property. There have been several other incidents which I can share when appropriate.

His actions are harassing in nature and are fueled with anger. He is violating basic privacy rights. He has the same behavior towards other STR owners on our block, with whom I have had ongoing conversations.

I look forward to presenting this in person next week and to seeing what remedies we can pursue.
