#### **BACKGROUND:**

### **Summary**

On November 28, 2022 (Minute Order 3.7) the Board of Supervisors approved the First Quarter Adjustment Report submitted by the Executive Office. The report included a recommendation to assist the Sheriff's Department in completing numerous pending projects. The Executive Office recommended tracking the reimbursement of these projects by transferring \$16,082,667 from the General Fund to the Capital Improvement Program (CIP) Fund. Of the 77 projects submitted by the Sheriff Department, 36 projects exceed a total project cost of \$100,000 or more and therefore require approval for inclusion in the Capital Improvement Program (CIP). As the Sheriff's Department incurs costs for these ongoing projects, a request for reimbursement from the CIP Fund will be submitted to the Executive Office monthly. The project balances will be monitored and adjusted by the Executive Office as necessary to accommodate operational changes and cost fluctuations. The total Sheriff Department project reimbursements will not exceed \$16,082,667.
