BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

- Angel View's Therapeutic Day program provides adults with disabilities the ability to create art and dance to help grow motor skills, physical fitness, stress relief and improved confidence. CID funds will help offset the expenses of Angel View's Day program.
- 2. Coachella Valley Community Trust provides access to resources and support for youth experiencing barriers such as poverty, abuse, disabilities, inequality, alienation and low school performance. CVCT is collaborating with Hope Through Housing, Desert Recreation District, and the City of Indio to provide after-school programing at Desert Meadows Kids Club. The goal is to provide supervision and assist with homework, youth mentoring and positive activities. CID funds will help purchase activity supplies.
- 3. Coachella Valley Disaster Preparedness Network's mission is to prepare all citizens of the Coachella Valley for catastrophic events by providing training, education, and networking opportunities. CVDPN is working to create a disaster preparedness brochure in Spanish to distribute in the Eastern Coachella Valley. CID funds will be used to cover the cost of printing tri-fold brochures.
- **4.** The Desert Recreation Foundation hosted their 2nd Annual Bowling Tournament to help raise funds for their Financial Assistance program. The tournament supports the Foundations mission to provide equitable, accessible, and inclusive recreational opportunities for the residents of Desert Recreation District.
- 5. Daughters of Love, inc. provides transitional housing for pregnant and/or parenting women who are experiencing a crisis. Clients receive education, counseling, training, shelter care and life skills. They are also provided with an Independent Living Plan to measure their progress toward obtaining independent living. CID funds will be used towards expenses to carry out this program like rent, food, transportation, furniture, and household items.
- **6.** Learning to Learn will host a Juneteenth Essay contest and celebration to develop an African American Cultural event in Desert Hot Springs. The program emphasis on essay writing will reinforce middle and high school students who enter the contest and attend the event to learn of African American history. CID funds will be spent on the expenses related to the production of the event, including but not limited to food, entertainers, equipment, and supplies.

- **7.** Eventscape International Inc. funding will support the Mobius Conference which provides spaces for intellectual exchange on important topics. Community leaders and students from diverse programing come together to empower and educate.
- 8. Read with me Volunteers mission is to assist local children from a low income, limited English speaking environment to develop their fullest potential by helping them learn to read, comprehend, and speak English, while understanding that people care about them as individuals. CID funds will be used for recruitment, registration, and training volunteers.
- **9.** United Way of the Desert is celebrating their 50th Anniversary at the 31st Annual Gala. The event will raise funds to support their family assistance programs, including Family Support Fund, Help 2 Others Water Assistance, and Raising A Reader early literacy program for local pre-k and kindergarten children.
- 10. The World Affairs Council of the Desert (WACD) annually hosts the Academic WorldQuest Competition where teams of Coachella Valley high school students compete academically and the winning team travels to Washington, DC, to compete in the World Affairs Councils of America National Competition. CID funds will be used to assist with cash awards, and travel expenses for the national competition.
- 11. The Youth Advisory Council hosts an Annual Youth Summit event for high school students to provide them with an opportunity to discuss topics that are affecting their lives and community. Professional and resourceful speakers will be in attendance along with 15 community resource exhibitors. CID funds will help with transportation for students.

SUMMARY OF RESOLUTION NO. 2023-104 A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE OF INTENTION TO ESTABLISH A COMMUNITY FACILITIES DISTRICT AND TO AUTHORIZE THE LEVY OF SPECIAL TAXES AND SETTING A DATE AND TIME FOR A PUBLIC HEARING THEREON

This summary is presented pursuant to California Government Code Section 53322. A certified copy of the full text of Resolution No. 2023-104, including a description of services and incidental expenses proposed to be financed and the proposed Amended and Restated Rate and Method of Apportionment, may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside, located at 4080 Lemon Street, 1st Floor, Riverside, California.

Resolution No. 2023-104 sets a public hearing on the Board of Supervisor's Intent to consider authorizing the levy of special taxes pursuant to the rate and original method of apportionment of special tax for Community Facilities District No. 23-4M (Highland) ("District"). The public hearing will be held on May 23, 2023 at 9:30 a.m., or as soon thereafter as the Board will consider the matter, at the meeting room of the Board of Supervisors, located on the first floor of the County Administrative Center, 4080 Lemon Street, 1st Floor, Riverside, California.

At the public hearing, testimony of all interested persons or taxpayers for or against the establishment of the District, the extent of the District, or the furnishing of specified types of public facilities or services will be heard. At the hearing, protests against the establishment of the District, the extent of the District, or the furnishing of specified types of public facilities or services may be made orally, or in writing by any interested person. Any protests pertaining to the regularity or sufficiency of the proceedings shall be in writing and shall clearly set forth the irregularities or defects to which objection is made. All written protests not personally presented by the author thereof at the hearing shall be filed with the Clerk of the Board at or before the time fixed for the hearing. The Board may walve any irregularities in the form or content of any written protest and at the hearing may correct minor defects in the proceedings. Written protests may be withdrawn in writing at any time before the conclusion of the hearing.

If 50 percent or more of the registered voters, or six registered voters, whichever is more, residing within the District, or the owners of one-half or more of the area of the land in the territory included in the District and not exempt from the special tax, file written protests against the establishment of the District, and protests are not withdrawn so as to reduce the value of the protests to less than a majority, no further proceedings to create the District or to authorize the specified special tax lien shall be taken for a period of one year from the date of the decision of the legislative body. If the majority protests of the landowners are only against the furnishing of a specified type or types of facilities or services within the district, or against levying a specified special tax, those types of facilities or services or the specified special tax shall be eliminated from the resolution of formation.

The proposed voting procedure for the proposal shall be by malled or hand-delivered ballot among the landowners in the District, with each owner having one vote for each acre or portion of an acre such owner owns in the District.

BE IT FURTHER RESOLVED, DETERMINED AND ORDERED that the Clerk of the Board of Supervisors is directed to give notice hereof as provided in Section 6063 of the Government Code.
