

BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

1. Angel Force USA - \$2,500 – The funding will be utilized for a fundraiser at March Air Force Base to support awareness of military suicides. The mission is to Stop SuiSilence, the avoidance of discussion about suicide.
2. Riverside County District Attorney’s Office-Division of Victim Services - \$4,000 – The funding will be used to support the National Crime Victims’ Rights Week, an annual event, which honors and brings tribute to victims of crime and their families by the Vigil and Memorial Wall.
3. Menifee Valley Chamber of Commerce - \$2,500 – The funds will be used for the Chamber Annual Awards Presentation that honors and supports exceptional businesses that demonstrate strong community involvement in the Menifee Valley area.
4. Camp del Corazon - \$650 – The funding will be utilized for a fundraiser to support children with congenital heart defects to go to a specialized camp with doctors and nurses.
5. Riverside University Health System Foundation - \$5,000 – The funds will be used to support the Foundation’s fundraiser ‘Pinwheels for Prevention’, a program that has focused on supporting the health and wellness of children, 0-21 years of age, in the foster care system.
