Authorize and direct the Auditor-Controller to issue a warrant to Global Discoveries, LTD., assignee for Ayesha Abdul Haqq heir to the Estate of Baheerah Abdul-Haqq AKA Paulette Booker, heir to the Estate of Clarence Booker in the amount of \$41,810.77, no sooner than ninety days from the date of this order, unless an appeal has been filed in Superior Court, pursuant to the California Revenue and Taxation Code Section 4675.
3. Authorize and direct the Treasurer-Tax Collector to transfer the unclaimed excess proceeds in the amount of \$41,810.76 to the County General Fund pursuant to Revenue and Taxation Code Section 4674.

BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the May 2, 2017 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 21, 2017. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 24, 2017, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

Revenue and Taxation Code 4676 (b) states that the county shall make reasonable effort to obtain the name and last known mailing address of the parties of interest. Then, if the address of the party of interest cannot be obtained, the county shall publish notice of the right to claim excess proceeds in a newspaper of general circulation in the county as per Revenue and Taxation Code 4676 (c). The Treasurer-Tax Collector's office has made it a policy to take the following actions to locate the rightful party of the excess proceeds.

1. Examined Parties of Interest Reports to notify all parties of interest attached to the parcel.
2. Researched all last assessee's through the County's Property Tax System for any additional addresses.
3. Used Accurint (people finder) to notify any new addresses that may be listed for our last assessees.
4. Advertised in newspapers for three consecutive weeks in The Desert Sun, Palo Verde Valley Times and The Press Enterprise referring any parties of interest to file a claim for the excess proceeds.
5. Sent out a certified mailing within 90 days as required by Revenue and Taxation Code 4676 (b).

According to Revenue and Taxation Code 4675 (a) Any party of interest in the property may file with the county a claim for the excess proceeds, in proportion to his or her interest held with others of equal priority in the property at the time of the sale, at any time prior to the expiration

of the one year following the recordation of the Tax Collector's deed to the Purchaser, which was recorded on June 21, 2017.

The Treasurer-Tax Collector has received one claim for excess proceeds:

1. Claim from Global Discoveries, LTD., assignee for Ayesha Abdul Haqq, heir to the Estate of Baheerah Abdul-Haqq AKA Paulette Booker, heir to the Estate of Clarence Booker based on an Assignment of Right to Collect Excess Proceeds dated February 5, 2018, a Joint Tenancy Grant Deed recorded April 26, 1956 as Instrument No. 1956-29695, a Notarized Affidavit for Collection of Personal Property on behalf of Clarence Booker dated October 31, 2017, a Certificate of Death for El Marie Booker AKA Marie Booker, a Certificate of Death for Clarence R. Booker, a Notarized Affidavit for Collection of Personal Property on behalf of Baheerah Abdul-Haqq AKA Paulette Booker dated October 31, 2017, and a Certificate of Death for Baheerah Abdulhaqq AKA Paulette Booker.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Global Discoveries, LTD., assignee for Ayesha Abdul Haqq heir to the Estate of Baheerah Abdul-Haqq AKA Paulette Booker, heir to the Estate of Clarence Booker be awarded excess proceeds in the amount of \$41,810.77. Since there are no other claimants, the unclaimed excess proceeds in the amount of \$41,810.76 will be transferred to the County General Fund. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimant by certified mail.

Impact on Residents and Businesses

Excess proceeds will be released to the heir of the last assessee of the property and transferred to the County General Fund.

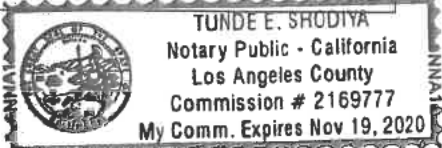

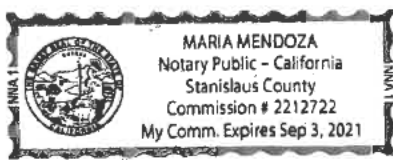

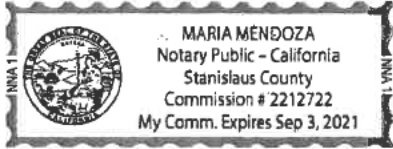

Clarence Booker and Marie Booker were the last record owners of the above referenced property per the Grant Deed recorded on April 26, 1956 in Riverside County, CA.

Marie Booker passed away on November 18, 1992. She left Clarence Booker as the surviving joint tenant for the above referenced Grant Deed.

Clarence Booker passed away on December 24, 2005 a Widow. He left behind two biological children; Baheerah Abdul-Haqq a/k/a Paulette Booker and Clarence Booker. To our knowledge he left NO Last Will and Testament, nor was his Estate ever probated in the State of California.

- **Please Note: We will refer to the son Clarence as "Clarence Booker, Jr." in order to distinguish between the father Clarence and the son Clarence.**

Clarence Booker, Jr. passed away on May 3, 2012, Never Married. To our knowledge he left behind one biological child; Camille Booker. **(Please See Exhibit A for the Certified Death Certificate for Clarence Booker, Jr.)**

To our knowledge he left NO Last Will and Testament, nor was his Estate ever probated in the State of California.

Baheerah Abdul-Haqq a/k/a Paulette Booker passed away on November 3, 2016, Divorced. She left behind one biological child; Ayesha Abdulhaqq. She had a predeceased child; Tariq Rashad White who was never married and had no biological or adopted children.

To our knowledge she left NO Last Will and Testament, nor was her Estate ever probated in the State of California.
