

BACKGROUND:

Summary

By Minute Order 3.59 of December 14, 2021, the Board of Supervisors entered into a contract with Hardy & Harper, Inc. of Lake Forest, California for the construction of the San Jacinto Street Resurfacing Project from Thornton Avenue to Florida Avenue, in the Community of East Hemet of Riverside County.

The original authorized amount of the contract was \$1,745,000. The total value of work came in at \$1,654,581 which is 5.2% lower than the originally authorized amount. The reduction of the total cost was the result of using less quantities than anticipated to complete the work.

The title of the Contract Documents and attachments for this resurfacing project solely included various locations within Supervisorial District 3. Due to revised Supervisorial District boundary limits implemented on January 2023, this project now has various Operational Districts with communities and project locations within the newly established Supervisorial District 5 that were previously identified as Supervisorial District 3 in the Contract Documents.

The work was completed in conformance with the plans and specifications and the contractor was granted relief of maintenance on September 1, 2022.

Impact on Residents and Businesses

The improvements benefit the project area by providing the public with a smooth paved roadway that will improve the safety and efficiency of vehicular traffic.

Contract History and Price Reasonableness

Seven bids were received on Wednesday, October 6, 2021 ranging from \$1,745,000 to \$2,630,738. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsive and responsible bid was submitted by Hardy & Harper, Inc. in the amount of \$1,745,000 which was \$223,428 (11.35%) below the Engineer's Estimate.

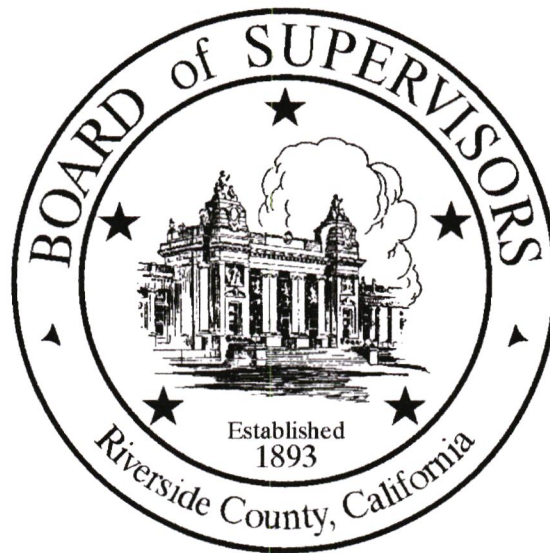
