- 1. The Coachella Valley Boxing Club has provided a no-cost facility, mentor and training to the youth of the Coachella Valley for over forty-five years. The Club supports over 150 individuals daily and as a result, the equipment provided experiences a great amount of wear and tear. CID funds will assist in the purchase of new boxing equipment.
- 2. The Desert Best Friends Closet educates and empowers their clients for success in employment and life. DBFC, Warriors to Work Veterans Initiative provides interview attire as well as access to their programs including Bridge to Employment to any U.S. Veterans seeking employment. CID funds will assist with the expenses for the Warriors to Work initiative.
- 3. Eventscape International Inc. held the Mobius Conference on April 19 & 20 and provided a space for intellectual exchange on important revolving topics. Community leaders and students attended the event to empower and educate. CID funds will assist with the expenses for production, transportation, food, and beverages. These are additional funds to board item 3.28 (04/04/23).
- 4. The Riverside County Department of Animal Services has a long history assisting community pet owners with the important process of spay/neuter to prevent unwanted pet population, protect the health of pets and help cut down on straying behavior of unaltered pets. CID funds will be used for a mobile spay/neuter clinic to improve the lives of pet families at the Oasis Mobile Home Park.
