BACKGROUND:

Summary

On November 8, 2022, Item 3.18, the Board of Supervisors (Board) approved the Edward Dean Revitalization Project (Project) In-Principle and approved the preliminary project budget of \$2,800,000 utilizing American Rescue Plan Act of 2021 (ARPA) infrastructure and economic recovery category funding. The Project will seek to upgrade the site septic, water quality and drainage improvements, hazardous material mitigation, Americans with Disabilities Act (ADA) compliance upgrades, and beautification improvements.

On January 5, 2023, the Office of Economic Development (OED) released a request for qualifications for architectural design services for the Project with an architectural statement of qualifications due date of January 26, 2023.

OED received eight statements of qualifications from the following firms (in no particular order):

- 1. Ware Malcomb of Ontario, CA.
- 2. obrArchitecture, Inc. of San Diego, CA.
- 3. Thirtieth Street Architects, Inc. of Newport Beach, CA.
- 4. STK Architecture, Inc. of Temecula, CA.
- 5. Westgroup Designs, Inc. of Irvine, CA
- 6. IDS Group of Irvine, CA.
- 7. Luce et studio of La Jolla, CA.
- 8. Garavaglia Architecture, Inc. of San Francisco, CA

On March 9, 2023, OED conducted interviews with the top two qualified architectural firms and on March 10, 2023, entered into price proposal negotiations with the most qualified firm, Westgroup Designs. After pricing negotiations, OED recommends the Board approve the Professional Services Agreement with Westgroup Designs to begin the development and design phase of the Project.

Impact on Residents and Businesses

The proposed funding responds to the negatively impacted tourism industry, provides health and safety improvements to the community, increases accessibility, highlights art and culture, improves library services, and intends to drive tourism which was most impacted by the COVID-19 pandemic. The Project will also improve the health and safety of patrons through upgrades to

storm and septic systems, mitigating downstream runoff and flooding, sewage backups and general access to the property during weather events.

Additional Fiscal Information

All costs associated with this Board action were previously approved on November 8, 2022 (Item 3.18) in the amount of \$2,800,000 and are 100% funded using ARPA funds. Contract expenditures for FY 22/23 are estimated at \$45,000; expenditures for FY 2023/24 are estimated at \$250,600; and expenditures for FY 2024/25 are estimated at \$100,000.
