3. Instruct the Clerk of the Board to return one (1) copy of Resolution No. 2023-009 to RivCoParks.



BACKGROUND:

Summary

Registered by the State of California as a point of historical interest in 1968, the Trujillo Adobe is one of the oldest remaining structures in the area. It has been managed by RivCoParks for more than four decades. The adobe is currently in a suspended state of disrepair, in dire need of preservation and restoration services that until recently were beyond the scope of funds available to RivCoParks.

Spanish Town Heritage Foundation, a non-profit organization dedicated to the preservation of the Adobe, has been long been a vocal advocate for its preservation. Their grassroots advocacy was vital in securing \$10.4 million dollars in Specified Grant funds through the offices of Senator Richard D. Roth, D-Riverside, and Assemblymember Jose Medina (AD61). The funds have been earmarked in the California State budget for RivCoParks to conduct preservation and enhancement of the Trujillo Adobe Historic Site in Riverside.

Among the requirements of the Specified Grant program is a resolution adopted by the governing body of the public agency applicant. The attached Resolution No. 2023-009 authorizes the application for and the acceptance of grant funding for the proposed project. It certifies that RivCoParks will comply with applicable laws and has sufficient funding to operate and maintain the project.

Impact on Residents and Businesses

This project will help to preserve a portion of the historic and cultural environment unique to Riverside County, making the Trujillo Adobe available to be enjoyed by residents for generations to come.

Additional Fiscal Information

This project will be funded entirely by grant funds. There is no associated match requirement.

12 responsibility by the Legislature of the State of California for the administration of a grant to the Riverside
13 County Regional Park and Open-Space District pursuant to Assembly Bill 179 and Section 19.56(10) (B)
14 of the 2022/2023 California State Budget; and

15 WHEREAS, Section 19.56(10) (B) of the 2022/2023 California State Budget designated
16 \$10,400,000 to the Spanish Town Heritage Foundation through the County of Riverside Regional Park and
17 Open-Space District for the preservation of Trujillo Adobe; and

18 WHEREAS, the State Department of Parks and Recreation has set up necessary procedures
19 governing application(s); and

20 WHEREAS, said procedures established by the State Department of Parks and Recreation
21 requires the applicant’s Governing Body to certify by resolution the approval of project application(s)
22 before submission of said applications to the State; and

23 WHEREAS, the applicant will enter into a contract with the State of California to complete
24 project(s);
