Moreno Valley College is partnered with Riverside County Fire to operate their academy at Ben Clark Public Safety Training Center. Individuals are educated and trained with the most up to date training platforms and equipment. In order to maintain a high level of training, Moreno Valley college is constantly looking to upgrade and replace the equipment students are using. The donation of the one (1) Ambulance will help ensure they maintain that standard.
