The Rotary Club of Indio has recently learned that the town of San Juan Bautista Tuxtepec, in the state of Oaxaca, Mexico with a population of 160,000, is in dire need of some firefighting equipment. They only have one fire station with a small all-volunteer force that wears street clothes. In addition, their two fire trucks are not in good shape, with one used only for transportation because its water pumps don't work.

The Indio Club wants to help by buying them a surplus county fire truck.

One of our Indio Rotary Club members, Jeff Gonzalez, his father lives there and is also a Rotarian. His father tells us about how the city does not have a working fire truck. There have been times buckets of water have been used to fight fires. Sometimes they have to just let a fire burn itself out because their capabilities are nearly non-existent. See the photo below of the fire consuming the former "Henrry" cinema of Tuxtepec, Oaxaca.

The Indio Rotary Club desires to purchase a surplus fire truck, equip it with the basics, and give it to the Tuxtepec Rotarians to then present it to the city. They have agreed to meet us at the border with the required paperwork and accept the truck. They are already planning a fiesta to celebrate the arrival of a fire truck.

In addition, we have contacted the old Indio Fire Fighters Association, from before the merger with the county Cal Fire, for advice on this matter, and they have offered to assist.

Much of what The Indio Rotary Club does is through our 501 (c)(3) foundation because it provides us with non-profit status. The foundation is registered with the Dept of Justice as a charity #53627, the Secretary of State and Franchise Tax Board #9788848, and the IRS #95-3842510.

Any support the county can offer to help us acquire a fire truck would be greatly appreciated by
