BACKGROUND:

Summary

The Riverside County Fire Department (RCFD) is an integrated, cooperative, regional fire protection system that provides fire, emergency medical services, technical rescue, and hazardous materials response to approximately 1.6 million residents in the unincorporated area, in 20 partner fire cities and one community services district. The RCFD is one of the largest regional fire service organizations in California. In cooperation with Cal Fire, it is committed to cooperative, regional and integrated fire protection and emergency services. They are an all-risk department devoted to protecting and serving County of Riverside residents and visitors.

The current *Fire Apparatus Technician I/II* job class series provides a critical role within RCFD by performing the necessary mechanical and electrical repairs, and adjustments on heavy duty gasoline and diesel-powered fire apparatus and related equipment, often under adverse conditions (**Attachment 2 & 3**). Incumbents are required to maintain a current *California State Fire Training Procedures Manual for Fire Mechanic/Emergency Vehicle Technician* certification (**Attachment 4 & 5**). Recently, the California Office of the State Fire Marshal introduced a new Emergency Vehicle Technician (EVT) 2022 program which expands the need for continued education and builds upon the current requirements (**Attachment 6**). Due to the additional certification requirements, and the absence of a class that can serve as a mentor for lower-level Fire Apparatus Technicians, RCFD is requesting to create a new lead-level job classification, titled *Fire Apparatus Technician III*. Through the review of the current class structure and continued growth in fire operations, it is apparent that the creation of a lead role that is responsible for reviewing and assigning the work of lower-level *Fire Apparatus Technician*'s and providing guidance to new or less experienced employees is needed (**Attachment 7**).

An external market review of the five surrounding counties was conducted for a lead level *Fire Apparatus Technician III* and yielded a market range of \$63,367 - \$86,840/year (**Attachment 8**). As such, it is recommended to use the five-county market and establish the *Fire Apparatus Technician III* job classification at a salary of \$63,367 - \$86,840/year.

Classification Addition

Fire Apparatus Technician III: It is recommended to add this classification to the Class and Salary Listing at salary plan/grade LIU 653 (\$63,367 - \$86,840).

Additional Fiscal Information

Fire Apparatus Technician III:

The Fire Department has allocated funding in their budget for the 2023/2024 fiscal year to utilize this new classification and will add the position(s) to their budget through the Classification Transaction Request (CTR) process at a later date. The creation of this classification will have no immediate cost for the department. However, the cost to add one Fire Apparatus Technician III will be approximately \$125,918 per position, including benefits.

RCFD has approved the recommended classification creation, which will be absorbed through their respective budget. A budget adjustment is not required.

Impact on Residents and Businesses

The addition of a new Fire Apparatus Technician III classification will provide a career growth structure to better equip staff performing critical services for the County of Riverside.

CLASS CONCEPT:

Under supervision, performs major and minor mechanical and electrical repairs and adjustments on heavy-duty gasoline and diesel powered fire apparatus and related equipment and trucks; and performs other related duties as required.

The Fire Apparatus Technician I is the first working level classification in the Fire Apparatus Technician series and reports to an appropriate supervisory or manager level position. Incumbents are assigned to maintain, diagnose, and make necessary repairs on fire apparatus and related equipment in the field, often under adverse conditions, or in a garage facility under the supervision of a shop supervisor. While on field assignment, incumbents must determine whether the equipment can be repaired in the field or must be sent to the garage for repairs.

The Fire Apparatus Technician I is distinguished from the Fire Apparatus Technician II classification in that the former is the first working level in which assigned incumbents may undergo the process of meeting the educational and certification requirements set forth in the California State Fire Training Procedures Manual for Fire Mechanic I (Fire Pumps and Accessories), whereas incumbents assigned to the latter class have met these requirements and may undergo certification at the Fire Mechanic II level.

EXAMPLES OF ESSENTIAL DUTIES:

(Depending on the area of assignment, duties may include, but are not limited to, the following)

· Inspect, diagnose, and repair mechanical failures and defects in fire apparatus and other equipment.

- Adjust, repair, replace, or overhaul a variety of diesel and automotive engines, transmissions, clutches, rear ends, differentials, transfer cases, hydraulic brake systems, axles, pumps, injectors, carburetors, final drives, sprockets, rollers, and truck and steering systems.
- Maintain, diagnose, and repair electrical defects, repairing or replacing starting motors, generators, and ignition systems; repair and overhaul fire suppression components and related equipment.

RECRUITING GUIDELINES:

Experience: Completion of an accredited heavy equipment mechanic apprenticeship-training program or successful completion of the California Fire Mechanics Academy, Inc. Fire Mechanic I (Fire Pumps and Accessories) course of instruction. One year of successful experience as a Heavy Equipment Mechanic or Senior Heavy Equipment Mechanic with Riverside County, or an equivalent class in another jurisdiction may substitute for mechanic apprenticeship or Fire Mechanic I certification.

Knowledge of: Principles of gasoline and diesel engines; heavy equipment maintenance and repair; methods, tools, equipment, and parts used in the repair and maintenance of construction equipment; operation and application of mechanical diagnostic equipment.

Ability to: Perform repair and maintenance work on heavy equipment; diagnose and repair mechanical defects in a variety of heavy-duty gasoline and diesel construction equipment in both the field and shop; operate equipment used in repairing or servicing construction equipment; read and understand shop manuals and mechanical diagrams; follow written and oral directions; perform work safely; work with minimal supervision.

OTHER REQUIREMENTS:

License: Candidates must possess a valid Class A or B Commercial California Driver's License. Depending on the area of assignment, the Department may permit the selected candidate to obtain the required licensure within six months of hire.

For those positions designated by the Department of Transportation (DOT) as safety-sensitive, applicants are required to complete a (DOT) mandated alcohol and drug-screening. Emergency Vehicle Technician 1 Certification / Recertification Instructions

Overview

The California Office of the State Fire Marshal Emergency Vehicle Technician (EVT) 1 Certification is based on the NFPA 1071: Emergency Vehicle Technician I Professional Qualifications set by the National Fire Protection Association (NFPA).

Persons with EVT 1 Certification are required to renew their certification every five (5) years. The recertification requires that the applicant completes 100 hours of approved continuing education (CE) and meet the all prerequisites stated in Recertification Requirements (Option B). All recertification applications must be postmarked on or before the certification expiration date. If the certified EVT 1 did not meet all recertification requirements by the expiration date, the EVT 1 Certification is considered to be lapsed.

If the EVT 1 Certification lapsed, the applicant will be required to complete 100 hours of CE in addition to the completion of additional CE hours. If the certification lapsed less than 6 months, you can regain EVT 1 Certification by completing an additional 8 hours of approved CE. If the certification lapsed between 6 months and less than 12 months, you can regain EVT 1 Certification by completing an additional 16 hours of approved CE. If the certification lapsed between 12 months and less than 18 months, you can regain EVT 1 Certification by completing an additional 24 hours of approved CE. For lapses, greater than 18 months, the applicant will need to retake all SFT courses listed in the Certification Requirements (Option A) Education section and reapply for initial EVT 1 certification, which will require the completion of a new Certification Task Book.

The California Office of the State Fire Marshal Emergency Vehicle Technician (EVT) 2 Certification is based on the NFPA 1071: Emergency Vehicle Technician I Professional Qualifications set by the National Fire Protection Association (NFPA).

Persons with EVT 2 Certification are required to renew their certification every five (5) years. The recertification requires that the applicant completes 100 hours of approved continuing education (CE) and meet the all prerequisites stated in Recertification Requirements (Option B). All recertification applications must be postmarked on or before the certification expiration date. If the certified EVT 2 did not meet all recertification requirements by the expiration date, the EVT 2 Certification is considered to be lapsed.

If the EVT 2 Certification lapsed, the applicant will be required to complete 100 hours of CE in addition to the completion of additional CE hours. If the certification lapsed less than 6 months, you can regain EVT 2 Certification by completing an additional 8 hours of approved CE. If the certification lapsed between 6 months and less than 12 months, you can regain EVT 2 Certification by completing an additional 16 hours of approved CE. If the certification lapsed between 12 months and less than 18 months, you can regain EVT 2 Certification by completing an additional 24 hours of approved CE. For lapses, greater than 18 months, the applicant will need to retake all SFT courses listed in the Certification Requirements (Option A) Education section and reapply for initial EVT 2 certification, which will require the completion of a new Certification Task Book.

The California Office of the State Fire Marshal Emergency Vehicle Technician (EVT) 3 Certification is based on the NFPA 1071: Emergency Vehicle Technician I Professional Qualifications set by the National Fire Protection Association (NFPA).

Persons with EVT 3 Certification are required to renew their certification every five (5) years. The recertification requires that the applicant completes 100 hours of approved continuing education (CE) and meet the all prerequisites stated in Recertification Requirements (Option B). All recertification applications must be postmarked on or before the certification expiration date. If the certified EVT 3 did not meet all recertification requirements by the expiration date, the EVT 3 Certification is considered to be lapsed.
