

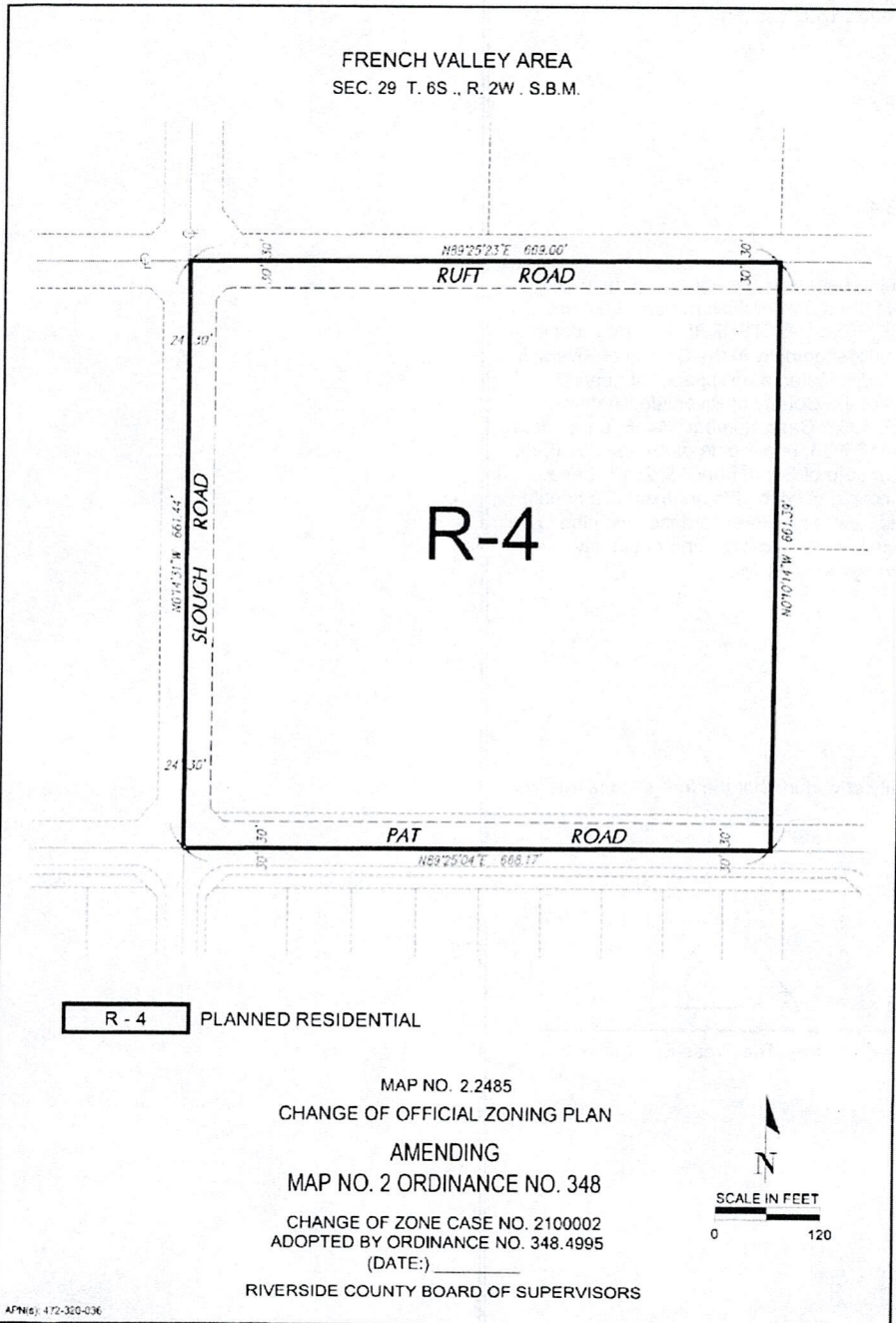

Section 4.1 of Ordinance No. 348, and official Zoning Plan Map No. 2, as amended, are further amended by placing in effect in the French Valley Area, the zone or zones as shown on the map entitled "Change of Official Zoning Plan Amending Ordinance No. 348, Map No. 2.2485, Change of Zone Case No. 2100002" which map is made a part of this ordinance.  
Section 2. This ordinance shall take effect 30 days after its adoption.
