**BACKGROUND:** Community Improvement Designation funds will be given to fourteen (14) 2023 High School graduates, who served on the Second District Youth Advisory Council (YAC), and are recipients of the Second District Youth Advisory Council Scholarship:

1. This scholarship was designed to reward Second District YAC members' hard work during their council year(s) to continue to improve our community and in the pursuit of their education and improve our community.
  - a. All YAC members graduating from the 12<sup>th</sup> grade were eligible to apply for this scholarship.

2. Eligibility considerations are as follows:
  - a. Must be a graduating senior attending a community college, public/private college or university, or eligible trade school.
  - b. Total number of hours that were contributed to the council.
  - c. Total number of years that the student has served on the Second District YAC.  
(Up to \$250 per year served)
  - d. YAC members must provide an essay that demonstrates what YAC means for them, growth while being a part of the council, and ideas or projects that they have contributed to the council.
  - e. Must provide acceptance letter and provisional transcript.
