

1. The donation to Blindness Support Services, Inc.(BSS) (\$4,000.00) will be used for the 25 Year Anniversary Celebration. BSS provides innovative approaches to achieving independence for people who live with Low or No Vision residing in the Inland Empire.
2. The donation to The Fruit of Our Hands (\$3,000.00) will be used for post COVID empowerment classes which will allow TFoOH to supply educational services (Financial Literacy, Credit Repair, Adult Education Tutoring, Empowerment classes, Career Path Assistance, and mentoring throughout Riverside County).
3. The donation to the Riverside County Sheriff's Office (\$2,500.00) will be used for the Sheriff's Annual Awards Ceremony which is an annual event that awards those Department members and members of the community who go above and beyond to better the cities/county in which they reside, and those who risk their lives to save the lives of others.
4. The donation to the Warrior Music Booster (\$3,500.00) will be used to support the Patriot Cardinal Regiment with new equipment – Patriot High School, Jurupa Valley.

5. The donation to Corona Heritage Foundation (\$4,000.00) will be used for the 2023 Antique and Collectables Faire. This is a free community event held at the Heritage Park and Museum.
6. The donation to Riverside Meals on Wheels, Inc (\$4,000.00) will be to support the Together, We Can Deliver program. This impacts a growing meal service for Riverside County housebound residents. Meals are delivered to senior and disabled neighbors in Riverside, Corona, Norco, Eastvale, and Jurupa Valley.
7. The donation to Janet Goeske Foundation (\$9,000.00) will be used for the Senior Legacy Awards Celebration. Seniors will be recognized for their many volunteer hours in the community.
