## BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

1. Oak Grove Institute Foundation - $\$ 25,000.00$ - Funds will be used for the 'Create, Play and Culinary Work Program' serving children with psychological, emotional and behavioral problems and special needs.
2. Boys \& Girls Club of Menifee Valley - $\$ 10,000.00$ - Funds to be used for operational expenses for the 'Boys \& Girls Club of Inland Valley Summer Program'; the purchase of a used van to transport kids on field trips, as well as the purchase of an AED (automated external defibrillator) for enhanced safety at the Clubhouse.
3. $5 \& 2$ Compassionate Ministry - $\$ 2,500.00$ - Funding for 'Community Food Shelf Distributions' at Gracepoint Church, with regular food distributions, twice a month, to help low-income families.
4. 7. Murrieta Chamber of Commerce $-\$ 2,000.00$ - The funding will be utilized to sponsor the Murrieta State of the City event, which brings civic leaders, residents and businesses together to celebrate accomplishments and acknowledge the future of Murrieta for the community.
