SUBJECT: RIVERSIDE UNIVERSITY HEALTH SYSTEM - BEHAVIORAL HEALTH: Approve and Authorize the Purchasing Agent to Issue a Purchase Order With TECH-OPS for Custom Mobile Therapy Units to Provide Parent-Child Interaction Therapy (PCIT) Services. All Districts. [\$811,330 Total for FY 2022/2023; Up to \$81,133 in Additional Compensation, 38% State, 25% Federal, 37% RUHS Foundation Donation]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and Authorize the Purchasing Agent to issue a Purchase Order to TECH-OPS in the amount of \$811,330 for custom Mobile Therapy Units to provide Parent-Child Interaction Therapy (PCIT) Services.
2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, based upon the availability of funding to modify the compensation provisions, not to exceed the sum total of ten percent (10%) of the approved Purchase Order amount through June 30, 2023.



BACKGROUND:

Summary

Riverside University Health System - Behavioral Health (RUHS-BH) operates a continuum of care system that consists of County-operated and contracted service providers delivering a variety of behavioral health treatment services within each geographic region of Riverside County.

The Children’s program is working towards a long-term sustainable plan to maintain the Prevention & Early Intervention Mobile Services (PEIMS) across the County. Services are provided to families who may not otherwise receive services due to transportation or other geographic barriers. They are also used to provide community outreach, education, and linkage to services during functions such as health fairs, school events, and other community activities.

As component of outreach and treatment, RUHS-BH is expanding and improving upon specialty field-based services. One of these services includes Parent-Child Interaction Therapy (PCIT), which is a successful evidence-based treatment focused on children aged 2-11 who struggle with behavioral issues. It is a unique treatment that looks a little different than traditional therapies. During a PCIT Therapy session, the parent and child engage in dedicated playtime while the therapist watches and provides live feedback to the parent through an earpiece. This program assists caregivers of children with behavioral problems by promoting positive parent-child relationships and interactions while teaching effective child management skills.

Specialty vehicles with modifications are required to perform Children’s PCIT services; therefore, RUHS-BH is requesting that the Board of Supervisors approve the Purchase Order with TECH-OPS as outlined herein.

Additional Fiscal Information

RUHS Foundation sourced and secured \$300,000 in donations from the community to assist in funding the procurement of these vehicles. The remaining cost will be funded with state and federal funding.
