BACKGROUND:

Summary

On February 2, 2021, the Board approved the tentative agreement for a five (5) year Memorandum of Understanding (MOU) between the County of Riverside and the Law Enforcement Management Unit (LEMU), effective February 2, 2021 through February 1, 2026. As part of that MOU, the parties agreed to form a subcommittee to perform non-substantive cleanup of the language, spelling, grammar, and formatting within the MOU after its approval by the Board.

On January 10, 2023, the Board approved the 2021-2026 LEMU MOU, which incorporated the tentative agreement along with substantive and non-substantive changes that were previously agreed upon by the aforementioned subcommittee.

Recently, it was discovered that Article VIII, Section 7 <u>Uniforms</u>, of the 2021-2026 MOU includes language indicating that certain classifications would receive a uniform allowance of \$60 per month. The language in this section was intended to indicate that certain classification would have their uniform allowance increased by \$60 per month from the amounts listed in the 2018-2020 LEMU MOU.

Per the 2018-2020 LEMU MOU, Sheriff's Sergeants, Correctional Sergeants, Coroner Sergeants and Supervising District Attorney Investigators would receive a uniform allowance of \$38.46 per pay period, while Sheriff's Lieutenants, Correctional Lieutenants, Coroner Lieutenants, Sheriff's Captains, Correctional Captains, and DA Bureau Commanders would receive a uniform allowance of \$19.23 per pay period.

Based on the intent of the 2021-2026 LEMU MOU, uniform allowances should have been increased by \$60 per month for Sheriff's Sergeant, Correctional Sergeant, Coroner Sergeant, Sheriff's Lieutenant, Correctional Lieutenant, Coroner Lieutenant, Sheriff's Captain and Correctional Captain. The correct uniform allowance amounts have been reported to CalPERS and also align with the intent of the parties; however, in order to be in compliance with CalPERS

regulations related to uniforms, CalPERS requires the governing body to adopt/approve reportable amounts. As such, Human Resources is recommending adoption of this side letter with LEMU, which amends the 2021-2026 LEMU MOU to correctly identify the appropriate uniform allowance amounts for each classification.

Additionally, adoption of this side letter will also add the Correctional Captain classification to Article II, Section 1 Recognition, which was inadvertently left off the 2021-2026 LEMU MOU.

Impact on Residents and Businesses

Approval of this side letter will have no direct impact on residents or businesses.

Additional Fiscal Information

There is no additional fiscal impact because the correct amounts have been paid to the employees and reported to CaIPERS.

SIDE LETTER OF AGREEMENT

BETWEEN

THE RIVERSIDE COUNTY LAW ENFORCEMENT MANAGEMENT UNIT

This Side Letter of Agreement ("Agreement") between the County of Riverside ("County") and the Riverside County Law Enforcement Management Unit ("LEMU") (collectively "Parties") is entered into with respect to the following:

WHEREAS, the Parties have entered into a Memorandum of Understanding ("MOU") with a term of February 2, 2021, through February 1, 2026; and

WHEREAS, the Parties wish to modify Article II, Section 1, Recognition, to include the Correctional Captain classification; and

WHEREAS, the Parties wish to modify Article VIII, Section 7, Uniforms, to accurately reflect the February 2021 agreement by the Parties to increase the existing Uniform allowance for Sheriff's Department classifications by \$60 per month; and

WHEREAS, the following sets forth the Parties' Agreement:

Uniform Allowance shall be provided on a per pay period basis. Uniform allowance will not be paid for any pay period where an employee was in unpaid status for the entire pay period.
