

**BACKGROUND:**

Community Improvement Designation funds will be given to the following organizations:

1. Mil Vet - \$10,000.00 the funding will be used for the Military Care Packages Program which provides care packages to military staff who are deployed overseas. The care packages are sent every month and packages contain support letters from youth and senior citizens, hygiene products and nutritious snacks.
  
2. Habitat for Humanity - \$90,000.00 – the funding will be utilized for the Home Repair & Preservation Program that offers minor and major exterior repairs to qualified low-income homeowners in the unincorporated county areas of Winchester, Homeland and Romoland.
  
3. New Birth Church Ministries- \$2,000.00 – the funding will be used for food supplies for the food pantry which serves low-income individuals in Southwest County.
