

BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

1. First 5 Riverside County - \$60,000.00 the funding will expand service capacity for So Cal Water Babies by training two additional swim instructors and offer 55 additional scholarships for Survival Float Program that instructs children six months-3 years residing in the Third District.
2. Anza Electric Cooperative Inc.- \$5,000.00 the funding will be utilized to pay for fuel for Find Food Bank trucks to deliver fresh food and non-perishable food supplies for a monthly food distribution to low-income residents living in Anza.
3. Hamilton Museum and Ranch Foundation- \$10,000.00 the funding will be used for the Founders Day Celebration and Barn improvements at the museum.
4. Rotary Club of Temecula Valley- New Generations- \$7,500.00 the funding will be used to support Michelle's Place Stocking Project which prepares Christmas stockings and gifts for children whose parents are receiving cancer treatment.

5. Impact Riverside Co.- Student of the Month Program- \$1,000.00 the funding will be used for recognition and scholarships for local high school students who reside in the Murrieta area.
6. Southwest Riverside Co. Association of Realtors Scholarships Foundation \$5,000.00 the funding will be utilized for college scholarships to high school students in the Southwest region.
