

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Riverside County Deputy Sheriff Relief Foundation will use funding to assist the families of the three deputies lost in 2023, as well as other families, members and deputies affected by these tragedies.
2. Riverside County Sheriff's Department will host their annual awards ceremony to recognize members of its sworn and non-sworn staff, as well as volunteers and community members for service and actions toward their fellow citizens. Recipients are presented medals, plaques, and other significant recognition awards.

3. Faith in Action of San Gorgonio Pass will use funding to assist low income, at risk, and homeless individuals navigate the health, workforce, and human services systems by increasing the access to primary care through culturally competent outreach and other resources.
4. Playhouse Bowl Association, Inc. will use funding towards their 70th Evening in the Park Summer Concert Series. This event is free to the public
5. Boys and Girls Club of the San Gorgonio Pass funding will be used to provide a summer camp at their Teen Center. The camp will serve teens ages 13-18 from June 5, 2023 through August 4, 2023. Various educational activities and lunch will be provided to over 100 teens.
6. Starting Line Strength and Stability Center will use funds for a low-cost or free membership to seniors diagnosed with Parkinson's Disease. The program will offer high intensity exercise classes to help stop or even reverse their symptoms as this can benefit to prevent falls and maintain the ability to stay living independently.
7. Hemet Valley Art Association, Inc. will use funding to continue to operate the gallery and to encourage and develop the appreciation, study and practice of the fine arts and to further educate, inspire and enrich the lives of others through their programs, exhibits and activities.
8. Cultural Alliance of the Pass will use funds to cover the cost of an alarm system due to vandalism and the cost of termite mitigation and repair. As a recognized Riverside County historical site, they would like to preserve it.
