#### **BACKGROUND:**

#### **Summary**

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the May 2, 2017 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 21, 2017. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 24, 2017, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received four claims for excess proceeds:

- 1. Claim from Richard Grandberry based on a Grant Deed recorded April 29, 2013 as Instrument No. 2013-0199607.
- Claim from the City of Banning based on a Notice of Abatement/Assessment Lien recorded November 26, 2007 as Instrument No. 2007-0712102 and a Release of Nuisance Abatement Lien recorded February 3, 2021 as Instrument No. 2021-0072420.
- 3. Claim from the County of Riverside, Department of Public Social Services based on an Abstract of Judgment recorded May 2, 2007 as Instrument No. 2007-0296673.
- 4. Claim from JoAnne Grandberry based on a Grant Deed recorded April 29, 2013 as Instrument No. 2013-0199607.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Richard Grandberry be awarded excess proceeds in the amount of \$69,227.84. The claim from the City of Banning be denied since claimant's lien was released with Instrument No. 2021-0072420 recorded on February 3, 2021. The claim from County of Riverside, Department of Public Social Services be denied since claimant was not a party of interest at the time of the sale. The claim from JoAnne Grandberry be denied since the claimant did not hold title at the time of the sale. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.
