- Jared Newman, 39, of Temecula was killed on July 4, 2023 when a single-engine Cessna 172 crashed after a touch-and-go landing near the French Valley Airport. The student airman was killed and his boys suffered major injuries.
- The following six people were killed when a Cessna business jet crashed early Saturday morning, July 8, 2023, near the French Valley Airport in Murrieta as a marine layer moved into the area. The flight had departed from Harry Reid International Airport in Las Vegas.
