

**BACKGROUND:** Community Improvement Designation funds will be given to the following organizations:

- 1. The FIATM Group, Inc. - \$3,000** funding will be used to support the Tutoring Education All Creating Hope (T.E.A.C.H.) Program that will assist youth within the communities by promoting a good value system, citizenship and increasing the high school graduation rate to universities.
- 2. Riverside County Office of Education Foundation - \$2,500** funding will be used to assist efforts to provide scholarships to disadvantaged high school students residing in the First District.
- 3. Taking It To The Streets with Lori and Shira - \$2,000** funding will be used to support the homeless with their pets by offering food, supplies for pets and funding for spay/neuter services to the homeless people encountered in Riverside and Jurupa Valley.
- 4. Passion to Love and Care Ministry - \$2,000** funding will be used to support Second Chances, a mentorship program that will assist youth with understanding of adolescent development.
- 5. The Grove Community Church- \$12,000** funding will be used to support the programs and services provided to First District residents at the Moses Schaffer Community Center in Good Hope.
