BACKGROUND:

Summary

The Riverside County Sheriff's Office – Lake Mathews Station was approached by FST Sand and Gravel (FST) regarding donating an off-highway vehicle for patrol purposes within the County area of greater Lake Mathews. FST worked with the Riverside Sheriff's Charities, Inc., a nonprofit public benefit corporation, to procure a 2023 Polaris General SXS outfitted with customizations specific to the Sheriff's needs and a 2023 Zieman Trailer.

FST saw the need for the Lake Mathews Station to have an off-road vehicle to respond to calls for service in the remote county areas serviced by the station and offered to supply funding for an off-highway patrol vehicle. The Riverside Sheriff's Charities, Inc. purchased a Polaris and Trailer for a total of \$39,699.98

Assets are identified as: 2023 Polaris G23GMK99BJ – Serial Number 3NSGMK99XPM394743 2023 Zieman F-816 Wood Bed Trailer – Serial Number 1ZCF20E23PZ36762

Upon approval, the Polaris and trailer will be registered with the California Department of Motor Vehicles as an off-highway vehicle and will be issued a County Asset Tag for tracking purposes.

The Polaris General is a 4-wheel drive SXS vehicle which is outfitted with GPS trail mapping, emergency and white light sources for identification and rescue operations. The Polaris is also equipped with a forward operating wench for rescue and recovery needs. The Polaris matches some current off-highway vehicles used in other Sheriff's stations and is compatible with their respective needs and capabilities. In addition, the GPS mapping onboard will link other SXS vehicles should the need arise in large scale deployments like missing persons, rescue operations and multi station deployments.

Impact on Residents and Businesses

Accepting the donation of this Polaris and trailer will greatly benefit the citizens in the Lake Mathews Station area. Since the station opened, there have been several off-roading

complaints made involving off-roading, illegal activity and two major injury crashes requiring law enforcement response. During some of the calls for service, several Sheriff's vehicles could not respond to the remote area without causing damage to the Patrol vehicle.
