#### BACKGROUND:

#### <u>Summary</u>

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the May 1, 2018 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 26, 2018. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 18, 2018, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of parties of interest reports, Assessor's and Recorder's records, as well as various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received two claims for excess proceeds:

- 1. Claim from Floyd J. Vail AKA Floyd J. Vail, Trustee based on a Short Form Deed of Trust and Assignment of Rents recorded January 6, 2005 as Instrument No. 2005-0015421, and a Note Secured by Deed of Trust dated December 27, 2004.
- 2. Claim from Global Discoveries, Ltd., Assignee for Oasis Medical, LLC based on an Assignment of Right to Collect Excess Proceeds notarized June 12, 2019 and a Grant Deed recorded January 6, 2005 as Instrument No. 2005-0015420.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that Floyd J. Vail AKA Floyd J. Vail, Trustee be awarded excess proceeds in the amount of \$57,768.79. Since the amount claimed by Floyd J. Vail AKA Floyd J. Vail, Trustee exceeds the amount of excess proceeds available, there are no funds available for consideration for the claim from Global Discoveries, Ltd., Assignee for Oasis Medical, LLC. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion. Notice of this recommendation was sent to the claimants by certified mail.

#### DECLARATION OF FLOYD J. VAIL

I, declare as follows:

1. My name is Floyd J. Vail and I am the trustor and trustee of the FJV Trust under instrument dated November 24, 1992. This declaration is being submitted in support of my claim for excess proceeds from the sale of Tax Defaulted Property.

2. As trustee, I sold the subject property to Oasis Medical, LLC a California Limited Liability Company ("Oasis") on or about December 27, 2004.

3. The original amount of the debt on the property was \$255,000. A promissory note secured by a deed of trust was received me. A true and correct copy of the promissory note is attached hereto as Exhibit A and a true and correct copy of the Deed of Trust is attached hereto as Exhibit B.

3. Oasis defaulted on the promissory note as of December 6, 2007. As of the date of default, I had received total payments that were applied to principal in the amount of \$18,946.56 leaving a principal balance due of \$236,053.

4. The Note required payments of interest at the rate of seven percent (7%) per annum. or \$23,605.30 per year. The interest for 10 years and four months, calculated from time of sale, is \$179,072.60 exclusive of the 6% penalty for each late payment.

5. The amount due and payable on the note secured by the deed of trust as of the date of sale of the tax defaulted property by the Treasurer-Tax Collector was \$415.125.60.


