

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. Riverside Area Rape Crisis Center - \$2,500 funding will be used to sponsor the 50th Annual Auction & Gala. The funds raised at this event will go to additional life-saving services free of charge to victims, survivors, and their families.

2. Riverside County Foundation on Aging Inc. - \$3,000 funds will be used to assist the Foundation with their Holiday Gift Program. Through this Program, seniors are selected from each senior center in the 1st District to receive a grocery store gift card to be used for the holidays.

3. Student of the Month Program, Inc. - \$550 funding will be used to support the Perris Valley and Menifee Chamber of Commerce with the local high school recognition program by providing scholarships and awards for First District students.

4. Rotary Club of Riverside - \$2,000 funds will be used to assist the Rotary's efforts to send high school students to the Rotary Youth Leadership Awards (RYLA), which is a

three-day Leadership Conference to help further develop their leadership skills and "Service Above Self" concepts to motivate and make a positive impact in their community.

5. Riverside Educational Enrichment Foundation - \$1,000 funding will be used to support both the Riverside Educational Enrichment Foundation (REEF) and Riverside Unified School District (RUSD) on their mission to provide teacher grants for art projects, field trips, equipment for sports and PE for over 43,000 students.

6. Perris Valley Filipino American Association, Inc. - \$1,000 funds will be used to support the arts and culture advocacy program in the Filipino American community.
