BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

- 1. Riverside County Foundation on Aging, Inc. \$10,000.00 The funding will be used to support the Foundation on Aging Grocery Market Gift Card/Nutrition Support Program for seniors in the Third District.
- 2. Menifee Santa's Workshop / Spark of Love \$5,000.00 The funding will be utilized to serve over 800 children, 350 families, between ages of infant 17 years, living in Menifee, Quail Valley, Romoland with a household income of Very Low, and Low to Moderate levels. Funds will be used to purchase learning products, books, science kits, music arts and crafts supplies, school supplies, hygiene products, backpacks, warm infant sleepwear, etc.
- 3. Menifee VFW Post 1956 \$5,000.00 The funding will be used for a program to assist local disabled Veterans and their families with unforeseen unmet needs, such as water heater repair, food supplies, home repair, etc.
- 4. Bike Temecula Valley, Corp. \$2,000.00 The funding will be utilized as a fundraiser for Community Mission of Hope that supports Southwest Food Pantry, Housing Resource Center, and Empowerment Village Campus.

- 6. Murrieta-Temecula Area Alumnae Chapter, Delta Sigma Theta Sorority \$2,500.00 The funding will be utilized as a fundraiser to support several youth activities (buy supplies for arts and crafts, school supplies, etc.) for children in low to moderate communities.
