BACKGROUND:

Summary 3 1

The Department of Animal Services ("DAS") is seeking authority to accept any donation, bequest, grant, or gift, with a value not to exceed \$50,000, monetary donations not to exceed \$50,000 per donation, in-kind donations of items with a value of no more than \$50,000 per donation, and the authority to accept and execute grant agreements or bequest documents for amounts not to exceed \$50,000 per grant made to or in favor of DAS for fiscal year 2023-2024.

Government Code ("GOV") § 25355 requires the Board of Supervisors ("BOS") to accept or reject any gift, bequest or devise made to DAS. The BOS is authorized under GOV § 25355 to delegate the authority to any county officer or employee to accept any gift, bequest or devise made to DAS. If the BOS authorizes the DAS Director, or designee, to accept grants and donations as requested, DAS will include an accounting of such grant, and bequest revenue in its report to the Executive Office and Auditor Controller's Office as part of the quarterly and year-end budget reports. If the proposed authorization is granted, any donations or grants that exceed \$50,000 will continue to be submitted to the Board of Supervisors for approval.

DAS applies for grants throughout the year to assist Riverside County residents with their pets. Allowing DAS to apply for and accept grants in a timely manner would streamline the process and enable staff to meet sometimes critical submission deadlines. DAS anticipates applying for grants to fund special outreaches, including, but not limited to, vaccines, microchips, programming, spay/neuter surgeries for Unincorporated Riverside County, emergency equipment, and veterinary supplies.

Impact on Residents and Businesses

The grants, bequests, devises, and donations that DAS receives have benefitted the residents and animals of Riverside County for years. Enabling the Department to accept and execute grant agreements without delay will assist DAS with meeting critical grant deadlines and accept funds quickly and efficiently.
