BACKGROUND:

Summary

The Riverside County Office on Aging (RCOoA) is requesting the purchase and procurement of four (4) outreach vehicles for department community efforts. Purchase of the vehicles will significantly enhance the department's ability to reach rural communities, provide nutrition education, nutrition counseling and outreach, in addition to supporting the delivery of meals to aging and vulnerable adults across the county, particularly during emergency and disaster events.

The RCOoA intends to utilize Older American Act state funds and Senior Nutrition Infrastructure funds allocated by the California Department on Aging for the full amount of the purchase. Senior Nutrition Infrastructure funds can only be used for the purchase of assets in support and for the enhancement of nutrition services. These additional baseline funds will be used to expand existing senior services and provide support to the department's outreach programs. The procurement process has been coordinated in close collaboration with Fleet Services and Purchasing, ensuring adherence to established guidelines and seeking the most reasonable price. Collaboration with these departments ensures compliance with procurement procedures and utilization of approved vendors previously used by other county departments for similar vehicle acquisition.

The Purchasing and Fleet Services Department requests an additional \$1,000,000 increase to previously submitted estimates for an amended annual budget. The amount reflects new state funds allocated to the RCOoA, for which the department is requesting to source and purchase commuter vans to support its Nutrition Outreach program efforts.

Impact on Residents and Businesses

The vehicle will be used to conduct RCOoA business operations to support community outreach and promote nutrition, health, and wellness free of charge to aging residents and vulnerable adults of Riverside County.

Additional Fiscal Information

There is no impact on the County General Fund. The purchase is 100% state funded by the California Department of Aging.
