BACKGROUND:

Summary

This is an initiation to amend Ordinance No. 348 (Land Use), to consider certain changes to Article XIXa (Temporary Events), related to large-scale temporary event operations, seasonal timeframes, and location criteria. The amendment will propose changes to the large-scale Tier VI events, and include new provisions for multi-day events, additional permitting and operating requirements, as well as clarifying where the events are allowed, based upon Zone Classifications.

Initiation Process

The Board of Supervisors Policy No. A-67 requires initiation of an ordinance amendment by the Board of Supervisors with the adoption of an order by an affirmative majority vote. If initiated, the proposed amendment to Ordinance No. 348 (Land Use) will begin the land use review process which includes the applicable environmental analysis, public review and input, and public hearings before the Planning Commission and then the Board of Supervisors.

Impact on Residents and Businesses

The proposed ordinance amendment would result in modifications to the Temporary Events article within Ordinance No. 348 (Land Use), related to large-scale temporary event operations, seasonal timeframes, and location criteria. Each proposed temporary event is reviewed on its own merits and has operational requirements imposed, designed to ensure the public health and safety. The review and approval process for Temporary Events is ministerial; however, depending on the size and scope of the event, multiple County departments including Fire and Sheriff, review and comment as needed.

Additional Fiscal Information

This project is a private application for an amendment to Ordinance No. 348 (Land Use), and as such, is funded through applicant submitted Deposit Based Fees (DBF). The planning process for this Project will commence upon initiation approval and is estimated to be completed this year.
