BACKGROUND:

Summary

In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the May 01, 2018 public auction sale. The deed conveying title to the purchasers at the auction was recorded June 26, 2018. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on July 18, 2018, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of Parties of Interest Reports, Assessor's and Recorder's records, as well as other, various research methods used to obtain current mailing addresses for these parties of interest.

The Treasurer-Tax Collector has received three claims for excess proceeds:

- Claim from All-Mobile Bail Bonds, Agent for Bankers Insurance Company based on an Authorization for Agent to Collect Excess Proceeds notarized June 9, 2023, a Deed of Trust recorded on May 03, 2016 as Instrument No. 2016-0177372, a Disclosure Statement dated April 13, 2016 and a Promissory Note dated April 13, 2016.
- 2. Claim Global Discoveries, Ltd., Assignee for Steven E Henson based on an Assignment of Right to Collect Excess Proceeds notarized August 27, 2018, and a Grant Deed recorded September 28, 2011 as Instrument No. 2011-0430046.
- 3. Claim from the County of Riverside, Code Enforcement Department based on a Notice of Pendency of Administrative Proceedings recorded July 18, 2014 as Instrument No. 2014-0264790 and a Notice of Pendency of Administrative Proceedings recorded April 04, 2017 as Instrument No. 2017-0133832.

Pursuant to Section 4675 of the California Revenue and Taxation Code, it is the recommendation of this office that All-Mobile Bail Bonds, Agent for Bankers Insurance Company be awarded excess proceeds in the amount of \$12,600.00, and Global Discoveries, Ltd., Assignee for Steven E Henson be awarded excess proceeds in the amount of \$55,325.47. The claim from the County of Riverside, Code Enforcement Department be denied since their liens were released with Instrument No. 2019-0314863 and 2019-0314864 recorded on August 16, 2019. Supporting documentation has been provided. The Tax Collector requests approval of the
