BACKGROUND:

<u>Summary</u>

On May 11, 2021 (Agenda Item 3.39), the Board of Supervisors adopted Ordinance No. 858.2, prohibiting illegal fireworks and approved the Fireworks Safety and Enforcement Action Plan. In 2021, a working group was established to create the Fireworks Safety and Enforcement Action Plan (Action Plan). The working group reconvened in May 2023 to revisit the Action Plan to ensure best practices from the previous year were implemented for the upcoming holiday. The Action Plan includes:

- Establishing Riverside County Sheriff Department (RSO) as the lead agency for deployment and enforcement.
- Placement of Changeable Message Signs (CMS) throughout the County in both English and Spanish.
- Staffing integration and deployment from RSO, Code Enforcement and Riverside County Fire Department.
- The issuance of citations.
- Implementation of the "You Light It, We'll Write It" messaging campaign.

Over the 2023 4th of July weekend, the Code Enforcement Department worked in conjunction with the Sheriff and Fire Departments on the issuance of civil penalties included in the ordinance. The Sheriff's Department issued 187 citations, made 1 arrest, and confiscated 831 pounds of fireworks. Additionally, the Sheriff dispatch center received a total of 3,209 fireworks related calls. Code Enforcement staff spent 484 hours on Fireworks Safety and Enforcement and issued a total of 46 citations. Riverside County Fire had a total of 681 incidents, issued four (4) citations for illegal use/possession of dangerous fireworks, seventeen (17) citations for unlawful off-road use, one fire closure citation, one unlawful burning citation and 249 calls for service, resulting in one of the busiest days the Department has had.

This year, new creative advertisements were developed by in-house personnel for the "If You Light It, We'll Write It" campaign. On April 18, 2023, the Board of Supervisors approved \$125,000 for a paid advertising campaign on traditional and digital media platforms, including digital freeway boards, local newspapers, broadcast radio, audio streaming, social media and digital display banners in both English and Spanish.

The advertising campaign reached the intended audience in a direct and diverse way, based on historical fireworks call volume provided by the Riverside County Sheriff's Department.

The new advertising approach allowed for increased tracking for the reach of the campaign, below is a summary of the results. An impression is a comprehensive estimate of the number of people who heard or saw one of the campaign's advertisements during the four-week campaign period.

- 4.6 million impressions across all online channels.
- More than 103,800 engagements and 4,500 site visits as a result of the impressions.
- 4.4 million radio impressions aired on 18 radio stations.
- More than 437,000 English and 188,000 Spanish impressions on Pandora and SXM.
- 9.3 million impressions on 13 digital billboards throughout Riverside County.

As a result of this tracking mechanism, the campaign team will use this data for recommendations for the 2024 campaign.

On April 18, 2023, the Board also approved \$25,000 to fund the placement and use of twentytwo (22) CMS boards countywide to be displayed from June 22, 2023 through July 5, 2023 with half of the signs in East County being in Spanish. Below is a list of the sign locations for the 2023 campaign.
