BACKGROUND: Summary

Riverside University Health System - Medical Center (RUHS-MC) requested Human Resources - Classification and Compensation (Class and Comp) to review the salary of the *Assistant Medical Records Manager* job class due to concerns that the current salary creates compaction with the subordinate, *Supervising Medical Records Coder* job class. Class and Comp verified the reporting structure and current salaries of the job classes above and determined that there was compaction as the *Assistant Medical Record Manager*'s minimum base salary and maximum base salary is <u>below</u> the *Supervising Medical Records Coder* (see Figure 1).

As such, it is recommended that the *Assistant Medical Records Manager*'s salary range be adjusted from \$60,007 - \$94,973/year to \$69,624 - \$103,693 to ensure a 5.5% difference to both the minimum and maximum base salary from the subordinate *Supervising Medical Records Coder* job class, which resolves the current compaction between these two job classes.

Salary Adjustments:

Assistant Medical Records Manager: It is recommended to adjust the salary plan/grade MRP 146 (\$60,007 - \$94,973) to salary plan/grade MRP 195 (\$69,624 - \$103,693).

Additional Fiscal Information:

There are no immediate upfront costs as the sole incumbent is currently earning above the new minimum rate. The department has approved the recommended salary adjustment and no budget adjust is required.

Impact on Residents and Businesses
