

BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. The Art Alliance of Idyllwild (AAI) is hosting their 25th Annual Art Walk & Wine Tasting event on October 14, 2023. The event supports the mission of AAI, which includes providing art scholarships, public art projects, art grants in support of local children, art exhibitions and artist workshops. The CID funds will be used to cover the cost of a free shuttle service during the event.
2. Eventscape International Inc. will host the 10th Annual Run with Los Muertos on November 4, 2023. The event collaborates with dozens of local agencies as well as international artists to provide art, culture, health and educational opportunities that celebrate the day of the dead holiday. CID funds will be used on equipment and supplies for the build out of Run with Los Muertos.
3. The Riverside County Foundation on Aging distributes grocery market gift cards to seniors in need during the holiday season. CID funds will be used to purchase gift cards that will be distributed to seniors throughout the 4th District.
