Kari was a cherished member of her family, leaving behind her devoted husband of 20 years, Joshua McGowan, and their beloved son, Liam McGowan. She is also survived by her twin sister Kimberly (Justin) Luyben, parents Art & Patty Tavizon, In-laws Tim and Melanie McGowan, mother-in-law Carla McGowan, brother-in-law Phillip (Marissa) McGowan, sister-in-law Caitlyn McGowan (Kathryn Sirp), and her beloved nieces and nephews Kailyn (Jacob), Emma, Grace, Justin Jr., Brendan, Shane, Elliott, & Wesley. She was preceded in death by her brother Bryan Cantwell.

MINUTES OF THE BOARD OF SUPERVISORS COUNTY OF RIVERSIDE, STATE OF CALIFORNIA



On motion of Supervisor Spiegel, seconded by Supervisor Washington, and duly carried by unanimous vote, **IT WAS ORDERED** that the meeting of Tuesday, October 3, 2023, be adjourned in memory of Dianne Feinstein, a beloved 90-year-old U.S. Senator from California, who passed away on September 29, 2023.

Senator Feinstein's dedication to public service began as an elected official in 1969 as a County Supervisor, a member of the San Francisco Board of Supervisors. In 1978, she became the first female board president. That year, on November 27th, her life was forever changed when Mayor George Moscone and Supervisor Harvey Milk were assassinated at City Hall by one of their colleagues. She discovered Harvey Milk's body after he was shot, and she broke the shocking news to the world. She displayed strength to the city and beyond, in the face of this tragedy, as she carried the city on and helped heal the city, as the mayor. She served two full terms as the first female mayor of San Francisco and led the city through the AIDS crisis.

In 1992, when Senator Feinstein ran for the U.S. Senate, only two out of 100 Senators, just two percent, were female. Today, there are 24 women serving in the U.S. Senate, and it will be 25 with Governor Newsom's appointment of Laphonza Butler. That year, 1992, Senator Feinstein and her longtime colleague Senator Barbara Boxer from California. became the first female pair of U.S. Senators to represent any state at the same time.

Senator Feinstein would go on to serve 30 years in the U.S. Senate. She was California's longest-serving Senator and the longest serving woman Senator ever. She made major contributions to California and the nation. She was also an advocate for Riverside County and helped our area on so many dif ferent fronts, whether it was her effectiveness on landmark legislation or her hard work behind the scenes. For example, it was her idea to create the Salton Sea Authority to unify the locals, the two counties, and the water agencies. She compiled many achievements on issues of importance to our region, from Salton Sea funding support, protection of California's desert, Indian compacts, and habitat conservation plans.

Senator Feinstein's many accomplishments include: The 1994 Federal Assault Weapons Ban; The Torture Investigation and Report, which led to outlawing the use of torture by the CIA; Protection of Same Sex Marriages; The California Desert Protection Act, and also recently Sand to Snow National Monument, Mojave Trails, and Castle Mountains National Monuments; Establishment of the Amber Alert National Child-Abduction Emergency Broadcasting System; The reauthorization of the Violence Against Women Act; The Lake Tahoe Restoration Act; Human Trafficking Reduction legislation to update the Trafficking Victims Protection Act; Cybersecurity legislation, the Cybersecurity Information Sharing Act; Consumer Advocacy such as the Do Not Call registry, legislation to stop rogue Internet pharmacies; bills to ban toxins in toy products; and other bills to protect consumers. She also helped set and expand the fuel economy standards for cars, trucks, and SUVs.

Senator Feinstein was an outstanding representative who believed in our democracy and was a role model for all people. Rest in Peace to an extraordinary woman, a champion for all. Her memory and passionate spirit will live forever in the hearts of those who knew and loved her. She will be greatly missed but never forgotten.
