

BACKGROUND:

Community Improvement Designation funds will be given to the following organizations:

1. Riverside University Health System Foundation - \$9,500.00 The funds will be used to support the Festival of Trees event, which focuses on essential needs of Pediatrics Department at the hospital.
2. Boys and Girls Club of Menifee Valley - \$2,500.00 The funds will be utilized for the annual fundraiser, which supports before-and-after school programs in the Menifee Valley area.

3. Boys and Girls Club of Southwest County - \$3,000.00 The funds will be used for the annual fundraiser "Our Kids Rock", which funds operational and program cost for three club houses at four middle school locations in the southwest area.
4. MilVet - \$1,200.00 The funds will be utilized to support active-duty military members, veterans, and their families. In addition, they send monthly military care packages, provide emergency veteran assistance, and a Holiday for Heroes program for children.
5. Fair Housing Council of Riverside County, Inc. - \$2,000.00 The funds will be used for the Champions for Justice Event, which supports fair housing objectives for renters, homeowners, and potential homeowners.
6. Rolling for a Cause - \$1,000.00 The funds will be utilized for a fundraiser, which provides micro funding for people on the verge of homelessness, or to stabilize individuals and families, who are waiting for public assistance.
7. Riverside Medical Clinic Charitable Foundation - \$1,500.00 The funds will be used to launch the 9th Annual Bullying Prevention Conference in Riverside. Community Leaders, Law Enforcement, Psychologists will address the bullying epidemic to students.
8. Antelope-Menifee Rural Center - \$8,500.00 The funds will be utilized for the Heating / Air Conditioning system replacement at the Community Center.
9. Voices for Children - \$10,000.00 The funds will be used for the Court Appointed Special Advocate Program, which provides children in foster care with caring adult volunteers, who advocate for their best interests.
10. Trauma Intervention Programs of Riverside County - \$1,500.00 The funds will be utilized to support recognition of first responders in law enforcement, fire departments, emergency room nurses and doctors, as well as TIP volunteers.
11. NAMI Temecula Valley - \$2,000 The funds will be used to support Caring Across Cultures: Multicultural Symposium on Mental Health. Participants will gain a deeper understanding of mental health in ethnically diverse communities.
