BACKGROUND/APPOINTEE INFORMATION:

Riverside County Children and Families Commission/First 5 Riverside (RCCFC/F5R) implements the provisions of Proposition 10, which provides tobacco tax funds to facilitate the creation and implementation of an integrated, comprehensive, and collaborative system of information and services to enhance optimal early childhood development and to ensure children are ready to learn and embrace lifelong learning.

The RCCFC/F5R was established by the Board of Supervisors as an independent agency through the adoption of Ordinance No. 784, enacted on January 22, 1999, and was subsequently reorganized by the Board through the adoption of Ordinance 784.9 enacted on June 9, 2009. On April 6, 2009, the Board of Supervisors designated RCCFC/F5R as a division within the Department of Public Social Services, effective July 1, 2009.

Dr. Wada has both executive-level physician administrator and clinical provider experience. He has extensive knowledge of IEHP, Medi-Cal, and Federally Qualified Health Centers both as a provider and payer; integration and direct operation of health services; continuous quality improvement and performance management methods; and organizational turnaround management.
