BACKGROUND:

Summary

The Supervising Storekeeper classification is used in the Fire Department and Riverside University Health System - Medical Center (RUHS-MC). The Service Employees International Union, Local 721 (SEIU) has requested that the County review the compaction between the Supervising Storekeeper and the subordinate level Storekeeper classification.

The results of the review illustrated that compaction exists between the two classifications as there is only a 0.96% spread between the classifications at the maximum rate. Per the SEIU MOU, Article 30, Section 2, supervisory classifications requiring salary adjustment due to compaction will be adjusted so that the deficiency of less than 5.5% in the maximum base salary of the supervisory classification is corrected. As such, it is therefore recommended that the maximum base salary of the Supervising Storekeeper classification be increased by approximately 4.54% to correct the compaction issue. This adjustment will ensure that the supervisory and subordinate levels are separated by the required 5.5% dictated by the SEIU MOU.

Salary Adjustment:

Supervising Storekeeper: It is recommended to adjust the salary plan/grade from SEUS 200 (\$43,960 - \$60,341) approximately, to SEUS 200 (\$43,960 - \$63,056) approximately. There is no immediate cost associated with this salary adjustment.

Impact on Residents and Businesses

The proposed compaction fix will have no direct impact to residents or businesses.

Additional Fiscal Information

There is no cost to this action as there will be no adjustments to any of the current incumbents.
