- 3. Direct the Clerk of the Board to deliver the Notice of Exemption to the Office of the County Clerk for filing within five (5) working days of this Board hearing; and
- 4. Direct the Clerk of the Board to cause a certified copy of this resolution to be recorded in the office of the Recorder of the County of Riverside, California.

C.E.O. RECOMMENDATION: Approve

BACKGROUND:

Eastern Municipal Water District has requested that the County of Riverside accept a portion of Main Street in the Good Hope area and Robinson Street in the Mead Valley area for public use for the purpose of installing water lines. Main Street (50.00 feet wide) was dedicated as Lot "I" on map titled Good Hope Country Club Heights, recorded in Map Book 12, Pages 64 and 65. Robinson Street (60.00 feet wide) was shown as "Road Easement" on Record of Survey, recorded in Book 31, Pages 34 through 36, inclusive of Records of Survey, both Records of the Recorder, of Riverside County, California. In 1996 Riverside County Day Labor crews improved Robinson Street to County Standards and the County has been maintaining Robinson Street ever since. Robinson Street has not formally been accepted for public use or maintenance by the County Maintained Road System and will accept portions of Main Street for public use. The Transportation Department has reviewed and approved of these acceptances.

As determined in the attached Notice of Exemption, the acceptance of the roadways is deemed Not a Project under CEQA per Section 15060(c) of the State CEQA Guidelines and is also deemed exempt from the provisions of CEQA pursuant to 15061(b)(3) of the State CEQA Guidelines. The acceptance will not result in any specific or general exceptions to the use of the categorical exemption and will not cause any direct or indirect physical environmental impacts.

County Counsel has approved resolution Number 2023-252 as to form.

Impact on Residents and Businesses

The acceptance of the roadways will not impact residents or businesses.

Additional Fiscal Information

All fees are paid by the applicant. There is no General Fund obligation.

NOTICE OF EXEMPTION

Description of Project: Accepting offers of dedication for a portion of Main Street in the Good Hope area for public use and accepting an offer of dedication for Robinson Street in the Mead Valley area for public use into The County Maintained Road System.

Name of Public Agency Approving Project: Riverside County Transportation Department, Survey Division, County of Riverside.

Name of Person or Agency Carrying Out Project: David L. McMillan, Riverside County Transportation Department, Survey Division, County of Riverside.

Exempt Status: California Environmental Quality Act (CEQA) Guidelines, Section 15061(b)(3), General Rule "Common Sense" Exemption. Not a "project" as defined under State CEQA Guidelines, Section 15060(c).

Reasons Why Project is Exempt: The acceptance of a street has been determined to not be a "project" as defined under State CEQA Guidelines section 15060(c). However, even if it was determined to be a project under CEQA for analysis purposes, the project is exempt from the provisions of CEQA specifically by the State CEQA Guidelines as identified below. The acceptance of the existing roadway will not result in any specific or general exceptions to the use of the categorical exemption as detailed under State CEQA Guidelines Section 15300.2. The project will not cause any impacts to scenic resources, historic resources, or unique sensitive environments. Further, no unusual circumstances or potential cumulative impacts would occur that may reasonably create an environmental impact. The acceptance of this street will not have an effect on the environment; thus, the County has deemed this does not meet the definition of a "project" under CEQA and no environmental impacts are anticipated to occur.

• Section 15061(b)(3) - General Rule "Common Sense" Exemption. With certainty, there is no possibility that the proposed project may have a significant effect on the environment. The acceptance of a street will not require any construction activities, change the use or intensity of the existing site to create a physical environmental impact, and would not lead to any direct or reasonably foreseeable indirect physical environmental impacts. Therefore, in no way would accepting of a street have the

potential to cause a significant environmental impact and the acceptance is exempt from further CEQA analysis.

 Section 15060(c) – for purposes of analysis under CEQA, accepting a street is not a "project" under CEQA pursuant to Section 15060(c). An action by a public agency is only a "project" subject to CEQA if the action might result in a physical change in the environment. Based upon a review of the whole action undertaken, supported, or authorized by the County, in no way will accepting a street increase the use of the site, result in increased development or construction impacts, or lead to any direct, indirect, or cumulative physical environmental impacts.

Based upon the identified exemptions above, the County of Riverside hereby concludes that no physical environmental impacts are anticipated to occur and the project as proposed is exempt under CEQA. No further environmental analysis is warranted.






